Brown and Caldwell and the City of Hollywood have a Professional Services agreement for General Engineering Consulting Services for Water and Sewer Infrastructure projects, approved by the City Commission by Resolution No. R-2009-214 on July 15, 2009; renewed by the City Commission via Resolution No. R-2013-110 on May 1, 2013; renewed again by the City Commission via Resolution No. R-2015-068 on April 1, 2015. The tasks included in the proposal will be implemented in phases and the services will be completed in approximately eighteen (18) months.
