

**FIRST AMENDMENT TO THE VEHICLE LEASE AGREEMENT BETWEEN  
THE CRA AND MYDATT SERVICES, INC. d/b/a Block By Block**

THIS AMENDMENT to that certain July 8, 2015 Vehicle Lease Agreement (the "Agreement"), is dated effective as of the \_\_\_\_ day of \_\_\_\_\_, 2016, (the "Effective Date") and is agreed to between the HOLLYWOOD COMMUNITY REDEVELOPMENT AGENCY, ("CRA"), and MYDATT SERVICES, INC. d/b/a Block By Block, an Ohio corporation duly authorized to do business in the State of Florida, ("CONTRACTOR"). It is hereby mutually covenanted and agreed by and between the parties hereto that said Agreement is amended upon the terms, covenants, and conditions hereinafter set forth.

WHEREAS, on November 6, 2014 the Hollywood, Florida Community Redevelopment Agency entered into an Agreement with Mydatt Services, Inc. d/b/a Block By Block for a Supplemental Maintenance Program (the "Agreement"); and

WHEREAS, execution of the Agreement was authorized via Resolution DCRA-2014-57; and

WHEREAS, on July 8, 2015 the CRA and CONTRACTOR entered into a Vehicle Lease in furtherance of the responsibilities under the Agreement;

WHEREAS, the vehicle that is covered under the terms of the current agreement is no longer functional and has been pulled from service;

WHEREAS, the CRA has secured a replacement vehicle to be leased to CONTRACTOR under the same terms and conditions;

NOW, THEREFORE, in consideration of the mutual promises and understanding set forth herein, the parties hereto agree as follows:

1. That vehicle identified in Exhibit "A" is hereby amended as follows:
