AN ORDINANCE OF THE CITY OF HOLLYWOOD, FLORIDA, AMENDING CHAPTER 34 OF THE CODE OF ORDINANCES, ENTITLED "CODE OF ETHICS", CREATING A NEW SECTION 34.06 ENTITLED, "DOING BUSINESS WITH THE CITY PROHIBITED"; PROVIDING FOR A SEVERABILITY CLAUSE, A REPEALER PROVISION, AND AN EFFECTIVE DATE.

WHEREAS, the City Commission expressed a desire to prohibit any current member of the City Commission from doing business with the City of Hollywood, even under circumstances where an exemption to the State statutory prohibition may exist; and

WHEREAS, State law allows local governments to adopt ethical regulations that are more strict than those in the State statutes; and

WHEREAS, the City Commission finds it in the best interest of the City to adopt an Ordinance prohibiting a current City Commission member from selling, renting, or leasing any realty, goods or services to the City of Hollywood;

NOW, THEREFORE, BE IT ORDAINED BY THE CITY COMMISSION OF THE CITY OF HOLLYWOOD, FLORIDA:

<u>Section 1</u>: That Chapter 34 of the Code of Ordinances entitled "Code of Ethics" is hereby amended as follows:

## § 34.06 DOING BUSINESS WITH THE CITY PROHIBITED

(Coding: Words in struck through type are deletions from existing law; words underscored are additions).

No current member of the City Commission shall either directly or indirectly sell, rent, or lease any realty, goods, or services to the City from any business entity of which the City Commission member, or the City Commission member's spouse or child, is an officer, partner, director, or proprietor, or in which such City Commission member, or the City Commission member's spouse or child, or any combination of them, has greater than a 5% ownership interest.

<u>Section 2</u>: That it is the intention of the City Commission and it is hereby ordained that the provisions of this ordinance shall be made a part of the Code of Ordinances of the City of Hollywood, Florida, and the sections of this Code may be renumbered to accomplish such intention.

<u>Section 3</u>: That if any word, phrase, clause, subsection or section of this ordinance is for any reason held unconstitutional or invalid, the invalidity thereof shall not affect the validity of any remaining portions of this ordinance.

<u>Section 4</u>: That all sections or parts of sections of the Code of Ordinances, all ordinances or parts of ordinances, and all resolutions or parts of resolutions in conflict herewith be and the same are hereby repealed to the extent of such conflict.

<u>Section 5</u>: That this Ordinance shall be in full force and effect immediately upon its passage and adoption.
