A RESOLUTION OF THE CITY COMMISSION OF THE  
CITY OF HOLLYWOOD, FLORIDA, AMENDING  
RESOLUTION NO. R-2001-60 TO RESTRUCTURE THE  
PERMIT FEE FOR THE PLACEMENT OF SIDEWALK  
CAFÉ TABLES IN THE CITY OF HOLLYWOOD.

WHEREAS, on November 2, 1988, the City Commission passed and adopted Resolution No. R-88-164 determining that the annual permit fee for establishing or maintaining a sidewalk café pursuant to the sidewalk café ordinance shall be \$150.00; and

WHEREAS, on March 21, 2001, the City Commission passed and adopted Resolution No. R-2001-60 amending Resolution No. R-88-164 restructuring the permit fee and payment schedule as follows: Permit Application Fee \$75.00, First Time Permit Fee \$150.00, Annual Renewal Permit Fee \$25 per table, but not less than \$150.00; and

WHEREAS, on October 19, 2016, the City Commission passed and adopted PO-2016-20, which amended Chapter 124 of the Code of Ordinances to revise the regulations, standards and criteria for the establishment or maintenance of sidewalk cafes zones within the City and on FDOT right-of-way, and

WHEREAS, pursuant to Section 124.10(A) of the Hollywood Code of Ordinances, the annual permit fees for establishing and maintaining sidewalk cafes shall be established by resolution; and

WHEREAS, the fees associated with the placement of sidewalk café tables require adjustment to better offset the cost associated with administering the process by which applicants receive permit approval and rates charged by the City for the use of both City and FDOT right of way;

NOW, THEREFORE, BE IT RESOLVED BY THE CITY COMMISSION OF THE CITY OF HOLLYWOOD, FLORIDA:

Section 1: That it hereby adopts the following permit fee for sidewalk cafes:

Permit Application Fee:                ~~\$75.00~~                \$125.00

First Time Permit Fee: ~~\_\_\_\_\_~~ \$150.00

Annual Permit Fee Renewal: ~~\_\_\_\_\_ \$25.00 per table but not less than \$150.00~~

FDOT Right-of-Way Permit Fee/Renewal Fee: \$3.00 per square foot

City Initial Permit/Renewal Fee:

\$200.00 + \$25.00 per table

~~Payment Schedule: The twelve-month period for which a permit fee is valid shall begin on October first of each year and end on September thirtieth of the following year. The permit fee shall be prorated for any new applicant which first obtains a sidewalk café permit on or after April first and before October first of any year. The permit fee under the above circumstances shall be 50% of the permit fee set forth in the permit fee schedule set by resolution pursuant to Chapter 124 of the Hollywood Code of Ordinances.~~

Payment of Permit Fees: The twelve month period for which a permit fee is valid shall begin on October 1<sup>st</sup> of each year and end on September 30<sup>th</sup> of the following year. Payment of the permit fee is due at the time of issuance of the permit. For permits issued after November 1<sup>st</sup> of each year, City and FDOT permit fees shall be pro-rated on a monthly basis.

Section 2: That this resolution shall be in full force and effect immediately upon its passage and adoption.
