## RESOLUTION NO. R-DCRA-2016-\_

A RESOLUTION OF THE HOLLYWOOD, FLORIDA COMMUNITY REDEVELOPMENT AGENCY ("CRA") AMENDING THE ANNUAL BUDGET FOR THE DOWNTOWN DISTRICT OF THE CRA FOR FISCAL YEAR 2017; REVISING FISCAL YEAR 2017 REVENUES AND EXPENDITURES; AND PROVIDING AN EFFECTIVE DATE.

WHEREAS, on September 28, 2017, pursuant to Resolution No. R-DCRA-2016-35, the CRA adopted a Budget for Fiscal Year 2017 for the Downtown District of the CRA; and

WHEREAS, the Budget was adopted based on preliminary projections of Fiscal Year 2017 revenues and expenses; and

WHEREAS, Resolution R-DCRA-2016-35 specifically set forth that the Budget may be amended when final information is available and as may be otherwise advisable from time to time during the fiscal year; and

WHEREAS, on October 14, 2016, the final certified property values were made available by the Broward County Property Appraiser to the CRA; and

WHEREAS, the final certified property values are less than the projected values upon which the adopted Fiscal Year 2017 budget was based by the CRA; and

WHEREAS, the final certified property values and final millage rates are shown in Exhibit "C"; and

WHEREAS, since the adoption of the Budget, it is necessary to amend the annual budgeted revenues and expenditures, as more specifically described in Exhibit "A" and Exhibit "B" attached hereto and incorporated herein;

NOW, THEREFORE, BE IT RESOLVED BY THE HOLLYWOOD, FLORIDA COMMUNITY REDEVELOPMENT AGENCY:

<u>Section 1:</u> That it hereby approves and adopts the attached Fiscal Year 2017 Amended Budget as more specifically set forth in Exhibit "A", "B", and "C" for the Downtown District of the CRA.
