### **2017 City of Hollywood Legislative Priorities - Draft**

#### **Federal Priorities:**

- Sober home regulation
- Funding for programs to assist the homeless
- Funding for sewer infrastructure
- Federal funding for resiliency projects to protect infrastructure
- Funding for beach renourishment and sand by-pass project

#### **State Priorities:**

- Vacation Rental Regulations – return to home rule
- Ocean outfall – funding for closure of the ocean outfalls
- Funding for planning for sea level rise and implementation of mitigation projects (sea walls)
- Funding and permitting of sand-by-pass project and beach renourishment
- Preservation of funds for local mitigation provision of the Seminole Compact
- Funding for septic to sewer conversions
- Funding for Tri-Rail Coastal Link

#### **Local Priorities:**

- Funding and permitting of sand-by-pass project and beach renourishment
- Use of Tourist Development Taxes

### **ISSUES TO MONITOR:**

#### **Federal:**

- Affordable flood insurance
- Submission of an application by Seminole Tribe to absorb city lands into the reservation
- Maintain/increase funding for CDBG and HOME programs under THUD bill
- Zika prevention funding

#### **State:**

- Preservation of the ability to charge a Local Business Tax and maintenance of the current rate for Communications Services Tax
- Daycare subsidies for low-income families
- Use of Tourist Development Taxes for Police/Beach Safety
- Allow for the installation of public safety cameras upon Florida Department of Transportation (FDOT) rights of way to provide municipalities the ability to operate a CCTV and LPR program.
- Fully fund the Sadowski Trust to be used for housing related activities
- Provide Senior Program Funding
- Repeal of recent revisions to Anchoring regulation restrictions FS327.4108 or a stricter regulation on anchoring
- Continuation of FS327.4105, pilot program for regulation of mooring vessels

- Reinstatement of Florida Recreational Development Assistance Program (FRDAP) funding levels
- Amend Florida State Statute Section 768.28 to expressly state that sovereign immunity constitutes immunity from suit to the extent not waived by applicable law
- Fund water and sewer infrastructure, coastal flooding, transportation, economic development
- Eliminate pre-emption and allow cities the authority to ban smoking on municipal property and regulate the use of Styrofoam and plastic bags
- Prohibit extensions on development permits granted by State law instead of by the local government
- Impact of increasing insurance costs upon homeowners and homeownership

- Update of the Broward County Land Use and Comprehensive Plan (Broward Next)
- Broward County's proposed affordable housing linkage fee
- Funding for programs to assist the homeless
- Broward County's proposed uniform housing study methodology
- Funding for Tri-Rail Coastal Link
- Continuation of County and Sheriff funding for Satellite Booking Station at the South Courthouse
- Use of Tourist Development Taxes- Cultural Tourism Programs and Tourist Development Capital Challenge Grant program
