Explanation:

This Resolution seeks authorization for the appropriate City Officials to waive the application fee and grant approval for planting a Memorial Tree and placing a Plaque in Lincoln Park in honor Alice D'Emilio, who recently passed away.

On September 21, 2016, an application was submitted seeking to create a memorial for Alice D'Emilio, a long time City of Hollywood Employee that was also the City Arborist. She designed many landscaping projects for the City and assisted in the landscape design for Lincoln Park.

Subsection 155.14(H) of the City of Hollywood, Code of Ordinances provides for the City Commission approval of naming and renaming of streets and City facilities and for the establishment of application fees and procedures adopted by Resolution R-2005-89. The City Commission amended the Procedures for the Naming and Renaming of Properties, Facilities, Parks and Memorials by Resolution Number R-2009-037. As per

the procedures, the City of Hollywood Naming Committee met on November 6, 2016 and approved the request. A copy of the committee's approval is attached.

This Resolution seeks to honor Alice D'Emilio with the planting of a Memorial Tree and the placement of a Plaque in Lincoln Park. Further, this Resolution states that the criteria for the naming of Properties, Facilities and Parks has been met and requests the waiving of the \$100.00 application fee, and, further, requests the waiving of the Notification requirements for Properties, Facilities and Parks.

The process for waiving is met by a 5/7 vote of the City of Hollywood Commission.
