Organization's Background: Please provide a concise description of the Applicant Agency, including its history, years of operation, general mission statement, and primary services provided.

Chartered in 1965 by Boys & Girls Clubs of America (BGCA), Boys & Girls Clubs of Broward County (BGCBC) has grown from one Club to 12, serving 12,500 young people annually between the ages of 6 and 18 years. The agency's mission is "to enable all young people, especially those who need us most, to reach their full potential as productive, caring, responsible citizens." This past program year, members spent over 2.7 million hours in their Clubs.

BGCBC has a proven track record of fiscal responsibility and is recognized as a leading advocate for youth, providing girls and boys with diverse after-school and summer activities that meet the interests and developmental needs of its members. Caring and passionate staff promote positive values about family and community, and guide members toward appropriate educational, personal, and vocational needs. Our equation for success includes programming in three core areas: *Academic Success, Good Character and Citizenship*, and *Healthy Lifestyles*:

- 1) Academic Success increase in grade-level advancement and reduced high school dropout rates; including mentoring, homework help, access to computers, i-ready reading and math program, career opportunity exposure and college and career fairs.
- 2) Good Character and Citizenship -- increased community service and reduced juvenile crime rates; safe, nurturing environment promotes strong, healthy relationships among peers, staff and parents.
- 3) Healthy Lifestyles increase in healthy behaviors and a decrease in drug use and obesity rates. Clubs offers free, nutritious snacks and hot suppers to all who attend directly affecting food insecurity and opportunity to participate in organized sport / gym activities promoting healthy eating and food choices. Trained staff serve families by connecting them to social services offered in Broward County such as 211 Broward.

BGCBC also provides Locally Developed Programs that introduce our teen members to specialized STEM (Science, Technology, Engineering and Mathematics) careers, culinary arts, media arts, and college readiness. It has been the goal of BGCBC to provide a world-class Club experience that assures success is within reach of every young person who walks through our doors. We want all members to graduate from high school with a plan for the future; demonstrate good character and citizenship by participating in leadership training and volunteering in community service projects; and engage in nutrition education and physical fitness activities that promote living a healthy lifestyle.

PROGRAM INFORMATION

1. How does your proposed project address the LETF Category (see above) as well as the Hollywood Police Department's Priority Area?

Boys & Girls Clubs of Broward County's (BGCBC) programs and operations are implemented with the upmost concern for the well-being of our members. By tailoring our programs to better respond to our members' needs, we are creating an environment that fosters their development. Therefore, more than just providing activities for our members, we are then able to provide programs that enrich our members' lives. BGCBC's staff and volunteers interact with our members daily. They serve as mentors to members, pushing them to set and achieve goals that will improve their lives. Unfortunately, many of our members live in neighborhoods with some of the highest crime rates and lowest standards of living in Broward County, thus placing these youth at especially high risk for involvement with alcohol, drugs, gangs, and other illegal activities. To combat this, Boys & Girls Clubs are open every weekday year-round, and on Saturdays during the school year, providing several hours of programming each day, thus enabling youngsters to be in a safe environment, away from the negative influences of the streets.

Surveys have shown that when a new Boys & Girls Club opens, juvenile crime in the area drops dramatically. In Broward County, this reduction has been as high as 46%. By steering our members away from delinquent activities, we provide an opportunity for them to thrive—academically, socially, and emotionally. Costing parents just \$15 per child for an annual membership, Clubs are equipped to provide positive stimulation for school aged youth. In addition to gameroom areas, there are computer labs, which are outfitted with desks, computers and appropriate educational software, gymnasiums, art rooms and several Clubs also house reading rooms. Hours of operation complement the school board's calendar to ensure that members always have a positive outlet for their time and energy outside of school hours. Summer and holiday hours are adjusted to provide service whenever school is not in season.

To address familial needs within our population, BGCBC has effective partnerships with the Broward's Sheriff Office, Women in Distress, Child Net, 211 Broward, the Mental Health Association of Broward and Nova Southeastern University's Mental Health Department. Club staff are trained regularly to identify mental health and behavioral issues in children and report any potential referrals to their Club Directors who can direct families towards receiving the appropriate care. A standing contract between BGCBC and NSU allows BGCBC to refer Club members struggling with mental health issues to a clinical psychologist in their Mental Health Department. In the event that BGCBC staff identifies a situation such as domestic violence or drug abuse occurring at home, BGCBC will refer the family to one of our many community partners that are best equipped for handling such cases.

2. Why is this funding needed (What community problem does it address)? What data suggests this program should be implemented with this population or in this geographical location?

Funding will benefit members attending the Marti Huizenga Boys & Girls Club located at 1111 North 69th Way, Hollywood, Florida, 33024. According to The Office of Juvenile Justice and Delinquency Prevention's (OJJDP'S) Socioeconomic Mapping and Resource Topography (SMART) system, the three tracts immediately surrounding the Huizenga Club have a community disadvantage index score of 7, 6, and 5; thus, those tracts are 70%, 60% and 50% more disadvantaged than other tracts in the country. Community Disadvantage Index Scores indicates the percentage of the local population that lives below the poverty line, receive public assistance, and the percentage of female-headed families with children. Club members face tough odds academically, socially, and financially. The majority of the feeder schools for the Marti Huizenga Club are Title I schools. During the 2015-2016 Program Year, 89% out of 1,428 members qualified for free and reduced lunch in their schools. This number is much higher than the 47.8% of students in Broward County which are eligible for free and reduced lunch (Annie E. Casey Kids Count Data Book). Additionally, 37% percent of member families at the Huizenga Club earn less than \$20,000 annually and 61% of members live in a single-parent home.

With these statistics in mind, our Club members are in need of programs that support graduation from high school, career preparation, nutrition education/assistance, and service learning projects, all which are provided at the Boys & Girls Clubs. Dedicated staff act as mentors, promoting positive behaviors while providing a continuity of support and friendship; things that many of our youth are lacking at home. Studies show that youth without a positive role model are more likely to engage in delinquent behavior. With the majority of our members residing in disadvantaged neighborhoods and financially burdened households, the Boys & Girls Club can fill this gap.

3. Program Summary (3-5 sentences): Provide an overview of program services.

Open to youth ages 6-18, the Marti Huizenga Boys & Girls Club provides out of school time activities and programming that meet the needs and interests of its members. Using BGCBC's equation for success, the Club provides programming in three core areas: Academic Success, Good Character and Citizenship, and Healthy Lifestyles. It has been the goal of BGCBC to provide a world-class Club experience that assures success is within reach of every young person who walks through our doors. We want all members to graduate from high school with a plan for the future; demonstrate good character and citizenship by participating in leadership training and volunteering in community service projects; and engage in sports and other activities that promote living a healthy lifestyles. If awarded, a grant from the City of Hollywood Police Department will go toward programs and operations at the Marti Huizenga Boys & Girls Club to support programs that the benefit Hollywood youth on a daily basis.

4. Describe the program in detail and how it will be implemented: (Describe Who, What, Where, and When) Please make sure your response includes program successes or challenges if previously funded, Why the agency needs the funding and its impact on the community. Established in 1992 and named after longtime BGCBC supporter and Board Member, Marti Huizenga, the Marti Huizenga Boys & Girls Club implements a diverse range of programs that respond to the needs of our youth. Considering the different learning styles of members, Boys & Girls Clubs of Broward County developed high-yield

educational programs that can be administered on a computer, using the arts or in small and large groups.

Youth Education Success

One of which, our Youth Education Success (YES) program, employs a comprehensive set of activities that reinforce what the student learns in school and builds his/her reading and math skills to promote grade level progression. YES begins with Power Hour, an hour of hands-on homework assistance, and is then followed by two hours of skill-building through common core aligned and individualized computer lessons and high-yield activities. Last year, 81 children at the Marti Huizenga Boys & Girls Club participated in the YES program.

Snack and Meal Program

The BGCBC Snack and Meal program offers members a healthy snack and hot meal Monday through Friday year-round and on Saturdays during the school year. The program provides members with healthy foods that they may not get at home due to limited income or insufficient information on healthy eating. Last year, members at the Marti Huizenga Boys & Girls Club served 98,369 snacks and meals to members. In 2015-2016, the Marti Huizenga Club distributed 1,470 Weekend Lunch boxes for members to take home that includes kid friendly meals to be eaten on Sunday when the Clubs are closed.

Physical Fitness and Nutrition

Encouraging members to take on a lifelong commitment to healthy nutrition and physical fitness is a top priority of the organization. Physical fitness activities at the Huizenga Club are suitable for all ages and abilities and include our Fitness Fun group activities, competitive athletic leagues in basketball, football and cheerleading, as well as introductory programs for tennis and golf. Our fitness programs and sports leagues improve our members' strength and endurance levels while also incorporating fair play, good sportsmanship and teamwork. The recent addition of a Tower Garden allows members to grow up to 28 fruits and vegetable plants, providing members with fresh produce to eat and learn about healthy lifestyle choices.

Art With A Heart

Art With A Heart, our year-round fine arts program, provides youth with a positive outlet for their artistic expression. The program provides weekly lessons and activities in drawing, painting, digital photography and other media for children of all ages. Beyond producing artwork for the Clubs, members have the richly rewarding opportunity to participate in local, regional, and national art exhibits, which provide the well-deserved attention and positive reinforcement that enable our members to thrive.

Volunteering

Clubs also provide opportunities for all members to engage in community service learning projects. BGCBC understands the importance of civic engagement among youth. As members reach out to the community, they are evolving into caring, empathetic citizens who lend a hand to their fellow community members and actively work to make their community a better place. Programs such as our Keystone Club for teenagers, Torch Club for pre-teens, and Youth of the Year, prepare members to be the leaders that their neighborhoods so desperately need. Members learn to elect officers and work together to implement activities in four areas: service to Club and community, education, health and fitness and social recreation.

College and Career Development

College Corner allows Club members who may have never considered college or who are unaware of the college

admissions process to receive hands-on assistance with all things college-related. It promotes higher education and higher level career aspirations to youth, and gives them the tools to get started on their professional journeys. A full-time youth development professional with a college degree mentors teens ages 14-18 on college choices, financial aid, the admissions process, and scholarships. Members from the Marti Huizenga Boys & Girls Club also attend the Annual Career Day and visit local colleges and universities during the summer.

Each year, teen members from the Marti Huizenga Boys & Girls Club attend the Annual Generals Construction Career Day (GCCD). During the GCCD, construction professionals lead hands-on activities with teen Club Members. Highlighted trades include air conditioning, crane operation, flooring, welding, landscaping and more! The program also offers OSHA 10 certifications and internship/job opportunities.

Teens are also exposed to additional career readiness programs such as CareerLaunch, Money Matters and SkillsUSA. With completion of the SkillsUSA program, members receive a certification in customer service and can get a job through BGCBC's collaborations with Board Members who own McDonald's and Wendy's restaurants.

Life Skills

The UPS Road Code program is a Teen Driving Program that teaches teen Club Members basic safety information and procedures while on the road. In 2015-2016, 15 teens from the Marti Huizenga Club completed the program and Maxine Delacruz, a member of the Marti Huizenga Boys & Girls Club, was chosen to serve as an ambassador to introduce the UPS Road Code Program to teens in their communities and help educate them and the general public on different safe driving principles.

5. Describe the Applicant Agency's experience in serving the target population and the capacity of the Applicant Agency to undertake the proposed program.

For over 50 years, Boys & Girls Clubs of Broward County's (BGCBC) emphasis has been on positively affecting children by ensuring that they have a safe and nurturing place to go when school is not in session. With a 4-star rating (highest rating awarded) from Charity Navigator for the sixth consecutive year, Boys & Girls Clubs of Broward County has a proven track record of fiscal responsibility and is recognized as a leading advocate for youth, providing an average of 12,500 youth annually in the community with a range of proven programs and services that instill a sense of competence, usefulness, belonging and influence. During the 2015-2016 program year, throughout Broward County:

- 96% of members who attended our Clubs progressed to the next grade level.
- 96% of senior members graduated from high school.
- 83% of senior members are enrolled in college.

Data from the Marti Huizenga Boys & Girls Clubs also shows that are programs are working, where last year:

- 96% of members progressed to the next grade level
- 100% of senior members graduated from High School
- 90% of senior members are enrolled in college
- 117,835 hours of physical activity performed
- 832 volunteers hours logged by members ages 10-18

Additionally, BGCBC takes multiple steps to ensure that the buildings are a safe, secure environment where members can enjoy the many programs offered and avoid harmful persons or behaviors that they might encounter had they not come to the Club. BGCBC has received the Markel Safety 1st Award for the second year in a row; one of only 6 Boys & Girls Clubs to receive the award for 2016. Each year, Markel's Safety 1st program recognizes policyholders who have shown an exceptional commitment to the safety of their employees and customers. Camps and Clubs must meet stringent criteria to qualify for the Safety 1st designation. They must have a proven safety record, undergo formal assessments and inspections, and participate in continuing education and certification programs. BGCBC also communicates with parents and guardians via the One Call Now communication system to quickly and efficiently update parents on program and safety happenings at BGCBC. The system allows us to communicate through a number of channels within minutes, leading to swift responses to any potential emergency situation.

BGCBC's approach to member safety includes not only modifications to Club facilities and revised policies and procedures, but increased understanding of staff that they are an important part of our members continued safety. Full-time staff members are required to hold a Bachelor's Degree and participate in youth development trainings in programming, safety and other relevant topics each year. Management Team, Board Members and Club Staff attend National Boys & Girls Clubs Conferences and local trainings hosted by the Boys & Girls Club Florida Alliance, Children's Services Council, and more. Additionally, safety trainings conducted by the Boys & Girls Clubs of America Delinquency & Gang Initiatives, Broward Sherriff's Office, the Nancy J. Cotterman Center, and Dr. Doug Laurie of American Heritage train staff in prevention and intervention techniques in the areas of bullying, sexual violence, armed intruders, and safety and security procedures.

BGCBC has successfully administered many grants by local, state and federal agencies, including Community Development Block Grants, municipal allotments, federal pass-through funding, and private foundation grants. Our organization has an outstanding history of successful grant administration. As a recipient of several grants from the Federal Office of Justice Programs, BGCBC has achieved outcomes and managed all funds and reporting requirements satisfactorily.






