A RESOLUTION OF THE CITY COMMISSION OF THE CITY
OF HOLLYWOOD, FLORIDA, APPOINTING FOUR (4)
MEMBERS TO THE COMMUNITY DEVELOPMENT
ADVISORY BOARD.

WHEREAS, the City Commission passed and adopted Resolution No. R-2015-168 establishing the Community Development Advisory Board (CDAB) consisting of eleven (11) board members whose primary responsibility is to make recommendations to the City Commission on matters involving the Community Development Block Grant (CDBG) Funds HOME funds and other federal funds that may be allocated; and

WHEREAS, pursuant to Resolution No. R-2015-168, the CDAB members shall be qualified electors in the City and priority shall be given to representatives from geographical areas of the City designated as qualified by the United States Census Bureau as having greater than 51% concentrations of low/moderate income (LMI) persons; and

WHEREAS, the CDAB has four (4) vacancies due to the expiration of terms for the following: Travis Bridges, James De Miles, Cliff Germano, and Andrew Zullo whose terms expire on June 30, 2017; and

WHEREAS, the City Clerk provided notice to the public that positions were available and solicited interest forms from citizens to fill available vacancies; and

WHEREAS, Cliff Germano submitted an application indicating that his residence was located in a LMI area, however, staff has confirmed that his residence is not in an LMI area; and

WHEREAS, Kyle Stabile submitted an application listing a P.O. Box as his residence, however, his street address was obtained, and staff has confirmed that his residence is not in an LMI area; and
