A RESOLUTION OF THE CITY COMMISSION OF THE  
CITY OF HOLLYWOOD, FLORIDA, APPOINTING ONE (1)  
MEMBER TO THE NEIGHBORHOOD WATCH ADVISORY  
BOARD.

WHEREAS, on June 17, 2015, the City Commission passed and adopted Resolution No. R-2015-167 which established the Neighborhood Watch Advisory Board to assist the Police Department in developing a Neighborhood Watch Program to be implemented throughout the City, promote crime prevention education and facilitate - crime programs in the neighborhoods, and facilitate neighborhood watch meetings; and

WHEREAS, on May 25, 2016, the City Commission passed and adopted Resolution No. R-2016-148 which amended Resolution No.R-2015-167 to increase the board membership by adding one (1) alternate; and

WHEREAS, there are two geographical zones for the membership with seven (7) members who reside in the eastern geographical zones and six (6) members who reside in the western geographical zones; and

WHEREAS, the eastern geographical zones consist of: Northeast Central, Southeast Central, Northlake, Southlake, Hollywood Beach, South Federal and the Downtown District; and

WHEREAS, the western geographical zones consist of: Boulevard Heights, Driftwood, 441 Corridor, Beverly Park, Northwest Central, and Southwest Central; and

WHEREAS, the members will serve in the geographical zones which are coordinated with the Police Department's Neighborhood Team Leader Patrol/Neighborhood Zones; and

WHEREAS, there are two (2) vacancies in the western geographical zone due to the resignations of Brandon Poltronieri (Boulevard Heights) and Marcy Decker (Driftwood) whose terms expire on June 30, 2018 and the remainder of their terms need to be filled, however, the City did not receive any applicants for these geographical zone areas; and

WHEREAS, currently, the Northwest Central western geographical zone is vacant due to the removal of Kettle Farquharson whose term expires on June 30, 2018 and the remainder of her term will need to be filled; and

WHEREAS, the City Clerk provided notice to the public that positions were available and solicited interest forms from citizens to fill available vacancies; and

WHEREAS, the following citizens have expressed a desire and willingness to fill the expired and/or vacant positions as follows:

Western Geographical Zones

Northwest Central: Samuel Bentolila

WHEREAS, Sieg Aurich submitted an application for which he would qualify for the eastern geographical zone of Northeast Central, however, the Northeast Central position is currently filled by Linda Hill Anderson whose term expires on June 30, 2018, and

NOW, THEREFORE, BE IT RESOLVED BY THE CITY COMMISSION OF THE CITY OF HOLLYWOOD, FLORIDA;

Section 1: That the following appointment is made to the following geographical zone:
