WHEREAS, the City Commission adopted Ordinance No. O-2010-30 removing the Civil Service Ordinance from the City Charter and placing it in the Code of Ordinances as approved by referendum on November 2, 2010; and

WHEREAS, the membership criteria for the vacant seats on the Civil Service Board are as follows; first, the member must be a continuous resident of the City of Hollywood and second, must meet one of the following criteria of the vacating seats: a) an individual employed or previously employed by the private sector in a non-management position; b) an individual employed or previously employed by the private sector in the area of personnel administration; c) an individual employed or previously employed by a public employer; and d) an individual self-employed or previously self-employed; and

WHEREAS, the term of Stanley G. Swiderski, serving as an individual employed or previously employed by the private sector in the area of personnel administration, is expiring on June 30, 2017; and

WHEREAS, the term of Dr. Jalane Meloun, serving as an individual employed or previously employed by the private sector in a non-management position, is expiring on June 30, 2017; and

WHEREAS, the vacant position/seat that was never filled, for an individual self-employed or previously self-employed, which expires on June 30, 2018, is required to be filled for a one-year term/period; and

WHEREAS, the term of Marie Woodson, serving as an individual employed or previously employed by a public employer; is expiring on June 30, 2017; and

WHEREAS, the City Clerk provided notice to the public and solicited interest forms from citizens to fill current and upcoming vacancies; and

WHEREAS, the following candidate has expressed interest in membership and qualifies for appointment to the Civil Service Board as an individual employed or previously employed by the private sector in the area of personnel administration:
