A RESOLUTION OF THE CITY COMMISSION OF THE CITY
OF HOLLYWOOD, FLORIDA, APPOINTING TEN (10)
MEMBERS TO THE AFRICAN AMERICAN ADVISORY
COUNCIL.

WHEREAS, the City of Hollywood African American Advisory Council was created in 1993 to act as a liaison between the African American community and the City; and

WHEREAS, R-93-352 established the African American Advisory Council, R-94-106 established board criteria and R-97-116 increased the membership to twelve; and

WHEREAS, R-2005-293 increased the membership of the African American Advisory Council (AAAC) from twelve (12) to thirteen (13) and two (2) alternate positions were created; and

WHEREAS, R-2011-333 increased the number of alternate positions from two (2) to three (3); and

WHEREAS, the current AAAC now consists of 13 members and three (3) alternates; and

WHEREAS, members must reside or work in the City of Hollywood, be of African American descent, and/or have extensive knowledge and interest in the African American community; and

WHEREAS, AAAC has six (6) member vacancies due to term expiration, Travis Bridges, Donna Comrie, Katlie Farquharson, Heather Mahoney, Mary Mites-Campbell, and Nila Williams; and

WHEREAS, AAAC has one (1) member vacancy due to the resignation of Howard Carter; and

WHEREAS, AAAC has three (3) alternate member vacancies due to the expiration of terms, Sheila Desir, John Houmes and a vacant not filled position; and

WHEREAS, the City Clerk provided notice to the public that positions were available and solicited interest forms from citizens to fill available vacancies; and

WHEREAS, the following individuals have expressed a desire and willingness to fill the vacancies, namely:
