A RESOLUTION OF THE CITY COMMISSION OF THE CITY OF HOLLYWOOD, FLORIDA, APPOINTING THREE (3) MEMBERS TO THE UNSAFE STRUCTURES BOARD.

WHEREAS, Section 116.13 of the Florida Building Code requires an Unsafe Structures Board be created which consists of nine members who shall be appointed by the City Commission; and

WHEREAS, all professional members of the Unsafe Structures Board shall be registered and licensed in the State of Florida; and

WHEREAS, the members of the Hollywood Unsafe Structures Board shall be appointed to serve three-year terms; and

WHEREAS, the composition and representative membership of the Board shall be one person per category as follows: Registered Engineer, Registered Architect, General Contractor, Electrical Contractor, Attorney-at-Law, Plumbing Contractor, Real Estate Appraiser, Real Estate Property Manager and Citizen with experience and background in the field of social problems; and

WHEREAS, currently, August Pujols serves in the position of Registered Engineer and his term expires on June 30, 2017, however, the City did not receive any applications for this position; and

WHEREAS, currently Michael Pratt serves in the position of Real Estate Appraiser and his term expires on June 30, 2017; and

WHEREAS, currently John Cruise serves in the position of Citizen with Experience & Background in Social Problem and his term expires on June 30, 2017; and

WHEREAS, the Registered Architect and the Plumbing Contractor positions were never filled; and these terms expire on June 30, 2018, and the remainder of these terms need to be filled, however, no applications were submitted for the Plumbing Contractor; and

WHEREAS, the City Clerk provided notice to the public that positions were available and solicited interest forms from citizens to fill available vacancies; and

WHEREAS, the following persons have submitted their Interest Form for consideration by the City Commission:
