HUB provides direct service and support for the hardware and software as a complete system as originally provided by FAAC / HUB. As a result of contracting with HUB, the City of Hollywood will be working with the system provider in a "factory direct" relationship. HUB Parking Technology USA Inc., Data Park and Magnetic Automation are all business entities of one larger global company, the FAAC Group.

The Data Park Management System Parking Control Software System and all of its components are proprietary to HUB and cannot be fully supported by any other company. This includes the DP 11000 Control Software, Data Park Entry Stations, Data Park Exit Stations, Data Park Cashier Fee Computers, Magnetic Barrier Gates, Validators and Interfaces & Software Integrations to the access control system Readers for the system. These products are all manufactured directly by business units of the FAAC Group as previously described. This hardware and software cannot be supplied nor converted by any other company.

HUB is the Sole Source provider, Manufacturer, Installer and Service Company for the parking control equipment installed and in use at the City of Hollywood.

HUB is the owner of the Intellectual Property and is the original designer and author of the source code of the Data Park Parking and Access Control System installed and in use at the City's parking facilities. This software system is licensed only to the City of Hollywood and for use in the Parking Facilities.

HUB is the provider of the hardware and software and performs all software maintenance for it with its own technical staff locally or with its remote help desk when such support is required.
