Cost Proposal

The cost proposal is included in the proposal pricing forms provided in the associated Microsoft Excel pricing spreadsheet.

CGI has developed and submitted an RFP response that is compliant to the City's requirements. We offer the right-sized solution, scope, and price for the ultimate success of the City's system. CGI is providing our built for government, CGI Advantage360 comprehensive ERP under a Software as a Service (SaaS) model. CGI is the single source provider of: software, implementation services, and ongoing infrastructure hosting and maintenance support. As such, the solution is necessarily developed and envisioned to be a bundled offering, as shown in the cost proposal.

Our pricing is reflective of nearly 40 years of experience developing and successfully delivering ERP systems to our clients. As such, our wealth of experience enables us to provide a solution and associated pricing that satisfies the requirements of this RFP without multiple change requests and additional expense. Our "out of the box" solution enables the City to implement the desired system with predictable pricing leveraging CGI's wealth of experience and success.

Importantly, a SaaS ERP solution offers the City significant advantages over legacy on-premise solutions including the avoidance of: hardware acquisition, data center support, in-house ERP related infrastructure and application knowledge, and costly upgrades.
