The submittal from Thunder Demolition Inc. was deemed non-responsive as they did not include Reference Forms, the Hold Harmless & Indemnity Form, the Non-Collusion Affidavit, the Sworn Statement on Public Entity Crimes, the Certification Regarding Debarment and Suspension Form, the Drug-Free Workplace Program Form or the Solicitation, Giving and Acceptance of Gifts Policy Form.

The Evaluation Committee consisting of three (3) City employees met to review and discuss the seven (7) responsive proposals received. The scoring criteria as outlined in the RFQ is as follows:

- 1. 20 Points Summary of Experience
- 2. 40 Points Pre-Qualification Questionnaire
- 3. 40 Points Project Experience

**100 Point Maximum Total** 

The RFQ document stated that "In general work to be performed shall be complete demolition of one (1) & two (2) family dwellings up to three (3) stories and commercial buildings up to four (4) stories including foundation, removal of asphalt and concrete driveways and parking, and the removal of concrete, chain link, or wood fencing. Additional related demolition requirements may be necessary on a site-specific basis."

The term of this agreement shall be for a period of three (3) years beginning upon date of award or expiration of current agreement, whichever is later. The City may renew this agreement for two (2) additional one (1) year periods subject to vendor acceptance, satisfactory performance and determination that the renewal will be in the best interest of the City.

The proposals were evaluated and the scores were compiled to arrive at the following rankings:

- 1. The BG Group, LLC 275 points
- 2. Cross Environmental Services, Inc. 273 points
- 3. Alliedbean Demolition, Inc. 260 points
- 4. Rick Hamann & Son Demolition, Inc. 255 points
- 5. Chin Diesel, Inc 254 points
- 6. Miami Wrecking Co. 247 points
- 7. A B Knight Construction & Development, LLC 152 points

The evaluation committee agreed that the RFQ submittals received by the six (6) highest rated firms would best meet the City's operational needs.

The evaluation committee requested that Procurement Services move forward with the RFQ award process based upon their recommendation to award a contract to the six (6) highest ranked firms. The Development Services Department and the Procurement Services Division will prepare a resolution requesting City Commission approval.

## **POST AWARD:**

If the City pre-qualifies a Contractor; he/she is designated to bid on future demolition projects. Notwithstanding any of the foregoing, a Contractor's pre-qualified status will be immediately suspended, if any material information contained in its pre-qualification application changes. Failure of the Contractor to give the City written notice of changes in the information previously provided, within ten (10) days before a bid opening will result in the Contractor being ineligible to bid on a project.
