## **Explanation:**

This Resolution seeks authorization for the issuance of a Blanket Purchase Order (B003047) between Maria Gamboa Bus Services, Inc. and the City of Hollywood for bus transportation services for the City's summer camp and aftercare programs for the term commencing on September 29, 2017 and terminating on June, 30, 2020 in an estimated annual dollar value of \$58,000.00.

The School Board of Broward County competitively bid for school bus transportation services, and on April 25, 2017, opened Bid #18-014R. This resulted in the award of three contracts, one of which was to Maria Gamboa Bus Services, Inc. for a three (3) year term commencing on July 1, 2017 and expiring on June 30, 2020. The City of Hollywood Department of Parks, Recreation and Cultural Arts desires to piggyback to use the School Board's bid subject to Section 38.40 (C)(5) of the City's Purchasing Order.
