

RESOLUTION NO. R-DCRA-2014- 51

A RESOLUTION OF THE HOLLYWOOD, FLORIDA, COMMUNITY REDEVELOPMENT AGENCY ("CRA"), AUTHORIZING THE APPROPRIATE CRA OFFICIALS TO ISSUE THE ATTACHED BLANKET PURCHASE ORDER BETWEEN MYDATT SERVICES, INC., DBA BLOCK BY BLOCK AND THE CRA FOR SANITATION AND SECURITY SERVICES FOR AN ESTIMATED ANNUAL EXPENDITURE OF \$299,869.87.

WHEREAS, the CRA requires supplemental sanitation and security services in the Hollywood CRA Downtown District and at the ArtsPark location; and

WHEREAS, in addition to sanitation and security services, duties will also include litter abatement, graffiti abatement and special projects such as installing lightpole banners and painting curbs; and

WHEREAS, the Coconut Grove Business Improvement District of Miami, Florida, issued its Request for Proposal (RFP) Number 14-601 on May 2, 2014, for the required sanitation and security services for an initial three (3) year term with the option to renew for an additional two (2) year period; and

WHEREAS, RFP Number 14-601 opened on June 5, 2014 and was subsequently awarded to the most qualified proposer, Mydatt Services, Inc., dba Block by Block of Nashville, TN; and

WHEREAS, Purchasing Ordinance, Section 38.40 (C)(5) allows the Director to procure, without following formal procedures, all goods and services which are subject of contracts with the state, its political subdivisions, the United States government, other governmental entities, or a corporation not for profit whose members are governmental entities, public officers, or any combination thereof, provided however, the goods and services are: (i) the subject of a price schedule negotiated by the state or the United States government, or (ii) the subject of a contract with another governmental entity or a corporation not for profit whose members are governmental entities, public officers, or any combination thereof, which contract is based strictly on competitive bids or competitive proposals and not on any preference; and

WHEREAS, Mydatt Services, Inc. of Nashville, Tennessee has satisfactorily provided similar services to Hollywood, Florida CRA for the past three (3) years; and

WHEREAS, the Executive Director of the CRA recommends that the CRA Board issue the attached blanket purchase order to Mydatt Services, Inc. dba Block by Block of Nashville, Tennessee for supplemental sanitation and security services for an initial three (3) year term for an estimated annual expenditure of \$299,869.87; and

WHEREAS, funding for the attached blanket purchase order has been provided for in the fiscal year 2015 budget in the Downtown Maintenance Account Number 66.0186.00150.552.015201 and will be budgeted in subsequent fiscal years;

NOW, THEREFORE, BE IT RESOLVED BY THE HOLLYWOOD, FLORIDA COMMUNITY REDEVELOPMENT AGENCY:

Section 1: That it hereby approves and authorizes the issuance, by the appropriate City Officials, of the attached Blanket Purchase Order between Mydatt Services, Inc., dba Block by Block and the CRA, together with such non-material changes as may be subsequently agreed to by the Executive Director of the CRA and approved as to form and legality by the CRA General Counsel.

Section 2: That this resolution shall be in full force and effect immediately upon its passage and adoption.
