On September 27, 2017, the City Commission via Resolution No. R-2017-288 adopted the FY 2018 Operating Budget which included General Fund allocation of \$180,000.00 for grants to agencies that provide social services to City of Hollywood residents and visitors. Prior to that, on March 29, 2017, the Community Development Advisory Board (CDAB) reviewed the twenty (20) eligible agencies that applied for such funding in FY 2018, along with their programs.

On April 6, 2017 the CDAB forwarded a recommendation of approval to the City Commission which is detailed in Exhibit 1 of the resolution. This recommendation proposes a General Fund allocation of \$180,000.00 which is the same funding level provided in the City of Hollywood Adopted Operating Budget for FY 2017 for the General Fund Agency Grant program.

Exhibit 1 provides the detail for the funding awards in the aggregate amount of \$180,000.00 which has been allocated and is available in the Fiscal Year 2018 Operating Budget in the Department of Financial Services Budget Administration Agency Grant account number 01.1205.00044.513.008200 for the purpose of providing these grant awards.
