A RESOLUTION OF THE CITY COMMISSION OF THE CITY OF HOLLYWOOD, FLORIDA, AUTHORIZING THE APPROPRIATE CITY OFFICIALS TO ISSUE THE ATTACHED BLANKET PURCHASE ORDER AGREEMENT BETWEEN CARMEUSE LIME & STONE, INC. AND THE CITY OF HOLLYWOOD FOR HIGH CALCIUM GRANULAR QUICKLIME IN AN ESTIMATED ANNUAL AMOUNT OF \$1,500,000.00.

WHEREAS, the Wastewater Treatment Plant Division of the Department of Public Utilities requires the purchase of high calcium granular quicklime; and

WHEREAS, the required quicklime was competitively bid by the City of Tamarac, Florida who acted as the lead agency on behalf of the Southeast Florida Governmental Purchasing Cooperative Group which the City of Hollywood is a member; and

WHEREAS, the City of Tamarac's Bid Number 17-22B was opened on July 11, 2017, and was awarded to the lowest responsive, responsible bidder by line item, Carmeuse Lime & Stone, Inc. for an initial term of three (3) years with the option to renew for three (3) additional one (1) year periods; and

WHEREAS, Carmeuse Lime & Stone, Inc. is currently providing these services to the City of Hollywood in a satisfactory manner; and

WHEREAS, the Director of Public Utilities and the Director of Procurement & Contract Compliance Officer recommend that the City Commission approve the issuance of the attached Blanket Purchase Order agreement for high calcium granular quicklime to Carmeuse Lime & Stone, Inc. in an estimated annual amount of \$1,500,000.00; and

WHEREAS, Section 38.46 of the Code of Ordinances authorizes the Director of Procurement Services to join with other governmental entities in cooperative purchasing plans when the best interests of the City would be served thereby; and

WHEREAS, award is subject to the City's receipt and approval of all insurance certificates required by the City's Risk Manager; and

WHEREAS, funding has been provided in the fiscal year 2018 budget in the Public Utilities Department's Chemical Supplies Account Number 42.4041.00000.536.005233 and will be budgeted in subsequent fiscal years;
