A RESOLUTION OF THE CITY COMMISSION OF THE CITY OF HOLLYWOOD, FLORIDA, ENDORSING THE FLORIDA DEPARTMENT OF TRANSPORTATION'S DELIVERY OF LANE IMPROVEMENTS FOR BICYCLE CERTAIN PROJECTS IDENTIFIED IN THE FDOT FIVE-YEAR ADOPTED WORK PROGRAM WHICH FALL WITHIN THE CITY OF HOLLYWOOD'S JURISDICTIONAL RIGHT OF WAY, SPECIFICALLY 72ND AVENUE BIKE LANES, FROM ROAD JOHNSON PEMBROKE ΤO STREET. WASHINGTON STREET BIKE LANES FROM 62ND AVENUE TO PARK ROAD, ALSO KNOWN AS THE HOLLYWOOD MOBILITY PACKAGE NO. 1 PROJECT NO. 431770-1-32-01.

WHEREAS, the City Commission supports the completion of missing sidewalk networks and designated bicycle lanes along the City's roadway system to provide safe pedestrian and bicycle pathways to protect residents from the traveling public and provide sustainable alternatives for mobility and transportation; and

WHEREAS, the City of Hollywood endorses the Hollywood Package No. 1 Project No. 431770-1-32-01 to receive funding from the Broward Metropolitan Planning Organization (Broward MPO); and

WHEREAS, through the Department of Public Work's efforts, the Broward MPO designated full project federal funding towards the Hollywood Package No. 1 Bike Lane Project No. 431770-1-32-01, providing for the construction of bike lanes along:

- 72nd Avenue from Pembroke Road to Johnson Street; widening to construct 4' bike lanes with 1 ' or 2' buffer
- Washington Street from SR -7 to South 56th Avenue, road diet by restriping to reduce four travel lanes to two lanes with center left turn lane and 4' bike lane.
- Washington Street from South 56th Avenue to Park Road, widening to construct 4' bike lanes
- Washington Street from S 62nd Avenue to SR-7, widening to construct 4' bike lane with 1' buffer

; and

WHEREAS the City of Hollywood endorses the Florida Department of Transportation (FDOT) delivering the Hollywood Package No.1 Project No. 431770-1-32-01 on the City's behalf, fully administering the design and construction phases of the project projects; and

WHEREAS, the City of Hollywood endorses the Florida Department of Transportation to deliver the projects within the City of Hollywood right of way/jurisdiction; and

WHEREAS, the City of Hollywood is responsible to maintain or coordinate the maintenance of the roadway after the project's completion;

NOW, THEREFORE, BE IT RESOLVED BY THE CITY COMMISSION OF THE CITY OF HOLLYWOOD, FLORIDA:

<u>Section 1</u>: That it hereby endorses the Florida Department of Transportation's delivery of bicycle lane improvements for certain projects identified in the five-year adopted work program which fall within the City of Hollywood's jurisdictional right of way, more specifically the Hollywood Package No. 1 Project No. 431770-1-32-01.

<u>Section 2</u>: That this resolution shall be in full force and effect immediately upon its passage and adoption.
