Explanation:

The City of Hollywood has been designated by the United States Department of Housing and Urban Development (HUD) as a participating jurisdiction for the receipt and use of funds as provided by the HOME Investment Partnership Program (HOME Program), which requires the City to set-aside not less than fifteen percent (15%) of the annual HOME allocation for investment only in housing to be developed, sponsored, or owned by a Community Housing Development Organization (CHDO).

Liberia Economic and Social Development, Inc. (LES) has been certified with the City as a CHDO, and has submitted a proposal for the use of CHDO funds for a CHDO-eligible project under HOME regulations.

On December 14, 2016, the City Commission passed and adopted Resolution No. R-2016-317 which approved an agreement with LES for this project. Subsequent to the passage of the Resolution, execution of the agreement was delayed.

This Resolution amends the term of the agreement, as well as the funding disbursement timetable in order for the City to meet applicable expenditure requirements.

Funding in an amount not to exceed \$81,666.30 will be made available in account numbers 11.1500.60557.554.008410 and 11.1500.60617.554.008410 subject to the rollover of available funds remaining at the end of FY 2017.
