A RESOLUTION OF THE HOLLYWOOD, FLORIDA COMMUNITY REDEVELOPMENT AGENCY ("CRA") AMENDING THE ANNUAL BUDGET FOR THE BEACH DISTRICT OF THE CRA FOR FISCAL YEAR 2018; REVISING FISCAL YEAR 2018 EXPENDITURES; AND PROVIDING AN EFFECTIVE DATE.

WHEREAS, on November 1, 2017, pursuant to Resolution No. R-BCRA-2017-44, the CRA amended the FY 2018 annual budget for the Beach District; and

WHEREAS, certain routine and periodic budgetary adjustments and transfers are appropriate; and

WHEREAS, since the adoption of the Budget and subsequent amendment, it is necessary to amend the annual budgeted expenditures, as more specifically described in Exhibit "A" and Exhibit "B" attached hereto and incorporated herein; and

NOW, THEREFORE, BE IT RESOLVED BY THE HOLLYWOOD, FLORIDA COMMUNITY REDEVELOPMENT AGENCY:

- <u>Section 1:</u> That it hereby approves and adopts the attached Fiscal Year 2018 Amended Budget as more specifically set forth in Exhibit "A" and Exhibit "B" for the Beach District of the CRA.
