A RESOLUTION OF THE CITY OF HOLLYWOOD, FLORIDA, AUTHORIZING THE CITY MANAGER OR DESIGNEE TO EXECUTE INDEMNIFICATION AGREEMENTS OR "HOLD HARMLESS" AGREEMENTS FOR PURPOSES OF FIRE RESCUE AND BEACH SAFETY TRAINING.

WHEREAS, the Fire Rescue and Beach Safety Department often encounters property within the City of Hollywood, such as vacant office buildings or open land, which is privately owned but that would be of great value for training purposes; and

WHEREAS, the owner(s) of these private parcels are often amenable to allowing the Fire Rescue and Beach Safety Department to conduct training on the owner's property; and

WHEREAS, the owner(s) of the private parcels will often request the execution of "hold harmless" or indemnification agreements in exchange for allowing the Fire Rescue and Beach Safety Department to conduct its training on their property; and

WHEREAS, the act of indemnification is a power reserved to the City Commission, except to the extent that the Commission delegates that authority to others in specific circumstances; and

WHEREAS, time is of the essence regarding these agreements because the buildings and property are often observed shortly before the property will be demolished, occupied, physically altered, or sold.

NOW, THEREFORE, BE IT RESOLVED BY THE CITY COMMISSION OF THE CITY OF HOLLYWOOD, FLORIDA:

Section 1: That the foregoing "WHEREAS" clauses are ratified and confirmed as being true and correct and are incorporated in this Resolution.

Section 2: That the City Manager or designees are authorized to execute indemnification agreements or "hold harmless" agreements with private property owners within the City of Hollywood when such agreements are required by private property owners in exchange for allowing the Fire Rescue and Beach Safety Department to conduct training on the owners' properties.
