A RESOLUTION OF THE CITY COMMISSION OF THE CITY OF HOLLYWOOD, FLORIDA, RATIFYING THE SUBMISSION BY CITY OFFICIALS AND IF AWARDED, ACCEPTANCE OF THE HARTFORD FIRE SAFETY EDUCATION GRANT IN AN AMOUNT NOT TO EXCEED \$10,000.00 TO PURCHASE FIRE SAFETY PUBLIC EDUCATION MATERIALS AND EQUIPMENT WITH NO REQUIRED MATCH; AUTHORIZING THE APPROPRIATE CITY OFFICIALS TO EXECUTE ANY AND ALL APPLICABLE GRANT DOCUMENTS AND AGREEMENTS; AND AMENDING THE FISCAL YEAR 2018 ADOPTED OPERATING BUDGET (R-2017-288) AS OUTLINED IN EXHIBIT 1.

WHEREAS, the Hartford fire safety education grant has grant funding available for the purpose of enhancing fire safety awareness and education within the community; and

WHEREAS, the Fire Rescue and Beach Safety Department desires to apply for the Hartford fire safety education grant to purchase fire safety public education materials and equipment to reduce the risk of fire and fire related injury or deaths throughout Hollywood; and

WHEREAS, these materials and equipment will be used to target communities in Hollywood which will be identified through a Community Risk Reduction program as having a high fire risk; and

WHEREAS, these public education materials and equipment will also be used throughout the year at various events such as the department's annual open house and Fire Prevention Week; and

WHEREAS, the Hartford fire safety education grant requires no cash match from the local government receiving the grant; and

WHEREAS, operational requirements necessitate certain adjustments to the Adopted Fiscal Year 2018 Operating Budget to promote greater productivity, effectiveness, and efficiency; and

WHEREAS, the Fiscal Year 2018 Operating Budget was adopted and approved by the City Commission pursuant to Resolution R-2017-288 at the second public budget hearing on September 27, 2017 (and subsequently amended); and

WHEREAS, if awarded, this funding will enhance the protection of the public from fire and fire related hazards.

NOW THEREFORE, BE IT RESOLVED BY THE CITY COMMISSION OF THE CITY OF HOLLYWOOD, FLORIDA:

Section 1: That the foregoing "WHEREAS" clauses are ratified and confirmed as being true and correct and are incorporated in this Resolution.

Section 2: That it ratifies the submission for the Hartford fire safety education grant in an amount not to exceed \$10,000.00 in order to purchase fire safety public education materials and equipment to enhance the protection of the public from fire and fire related hazards.

Section 3: That the City Manager is authorized to accept said grant, if awarded; provided, however, the City Manager shall have the discretion to refuse the grant in those circumstances where he determines it is in the best interest of the City to do so, in which case he shall advise the City Commission of his intention to refuse the grant.

Section 4: That the Amendments, Adjustments and Transfers to the Operating Budget of the City of Hollywood for the Fiscal Year beginning October 1, 2017 relating to the Special Programs Fund (Fund 11) set forth in detail in Exhibit 1, are approved, adopted and accepted as Amendments to the Operating Budget of the City for the Fiscal Year 2018.

Section 5: That the Department of Financial Services is authorized to establish such line item accounts as may be necessary to properly monitor and track said appropriations.

Section 6: That upon the Hartford fire safety education grant being awarded to the City, and the City Manager accepting said award, appropriate City officials are authorized to execute a grant agreement along with any other applicable documents in a form acceptable to the City Manager and approved as to form and legal sufficiency by the City Attorney.

Section 7: That this Resolution shall be in full force and effect immediately upon its passage and adoption.
