A RESOLUTION OF THE CITY COMMISSION OF THE CITY OF HOLLYWOOD, FLORIDA, ENDORSING THE FLORIDA DEPARTMENT OF TRANSPORTATION'S DELIVERY OF COMPLETE STREETS FOR CERTAIN **PROJECTS** IDENTIFIED IN THE FIVE-YEAR ADOPTED WORK SPECIFICALLY PROGRAM. MORE THE FEDERAL HIGHWAY COMPLETE STREETS PROJECT PEMBROKE ROAD TO SHERIDAN STREET, PROJECT NOS. 441582-1 AND 439991-1.

WHEREAS, the City Commission supports the implementation of complete streets for safe travel and access by all users utilizing varying modes of transportation and to promote a safe, healthy, livable and sustainable community; and

WHEREAS, the Broward Metropolitan Planning Organization ("Broward MPO") obtained federal funding to be appropriated towards complete streets projects; and

WHEREAS, through the Department of Public Work's efforts, the Broward MPO designated a portion of the project's costs through federal funding towards the Federal Highway Complete Streets Project From Pembroke Road to Sheridan Street, Project Nos. 441582-1 and 439991-1; and

WHEREAS, in an effort to optimize project implementation and provide cost and time savings, the City, Broward MPO and the Florida Department of Transportation ("FDOT") agree that the delivery of the two referenced projects, which include the necessary design, construction and project management services, is best provided for by FDOT; and

WHEREAS, FDOT requires the City to endorse FDOT's delivery of projects.

NOW, THEREFORE, BE IT RESOLVED BY THE CITY COMMISSION OF THE CITY OF HOLLYWOOD, FLORIDA:

<u>Section 1</u>: That the foregoing "WHEREAS" clauses are ratified and confirmed as being true and correct and are incorporated in this Resolution.

<u>Section 2</u>: That it endorses the FDOT's delivery of complete streets for certain projects identified in the five-year adopted work program, more specifically the Federal Highway Complete Streets Project from Pembroke Road to Sheridan Street, Project Nos. 441582-1 and 439991-1.
