A RESOLUTION OF THE CITY COMMISSION OF THE CITY OF AUTHORIZING THE HOLLYWOOD. FLORIDA, APPROPRIATE CITY OFFICIALS TO ISSUE THE ATTACHED BLANKET PURCHASE ORDER WITH ALLIGATOR ALLEY HARLEY-DAVIDSON OF **FORT** LAUDERDALE FOR THE LEASE OF SIX POLICE MOTORCYCLES FOR A TWO YEAR LEASE PERIOD AT AN ESTIMATED ANNUAL COST OF \$47,422.08.

WHEREAS, the Police Department requires the lease of six Harley Davidson FLHTP Electra Glide Police Motorcycles and repair and maintenance thereof, through an authorized Harley-Davidson dealer; and

WHEREAS, On November 15, 2017, Notice of Availability of Bid F-4564-18-JE was posted on the City's Website, advertised and sent to 976 firms and viewed by 21 vendors on Bidsync.com in accordance with the City's Purchasing Ordinance, Section 38.42 (A)(1); and

WHEREAS, Bid Number F-4564-18-JE was opened at 3:00 P.M., December 6, 2017, with responses from two bidders:

 Peterson's Harley-Davidson of Miami, L.L.C.
Miami, Florida (Option A) \$650.00/month/motorcycle (Non-Responsive)

(Option B) \$750.00/month/motorcycle

 Alligator Alley Harley Davidson Fort Lauderdale, Florida

\$658.64/month/motorcycle

; and

WHEREAS, the desired motorcycles will display the black paint scheme desired by the Police Department rather than a standard white paint scheme; and

WHEREAS, each motorcycle shall be equipped with a top of the line emergency lighting system and power outlet for radar units at no additional cost to the City; and

WHEREAS, Peterson's Harley-Davidson of Miami submitted two lease options for motorcycles and their Option A is considered non-responsive to the bid requirements as it does not meet the minimum requirements; however, their Option B

meets the requirements as listed in the bid specifications, but their monthly lease cost exceeds that of Alligator Alley Harley-Davidson; and

WHEREAS, Alligator Alley Harley-Davidson met all the requirements in the bid specifications; and

WHEREAS, Alligator Alley Harley-Davidson of Fort Lauderdale provides leased motorcycles to several local Police Departments throughout the tri-county area and a check of their references has been verified and proves to be satisfactory; and

WHEREAS, the Acting Chief of Police and the Director of Procurement and Contract Compliance recommend that the City Commission approve the issuance of the attached Blanket Purchase Order for the lease of six Harley-Davidson FLHTP Electra Glide Police Motorcycles at a cost of \$658.64 per month, per motorcycle, for a two year period, with the option to renew for one additional two year period, providing any renewals are in best interest of the City, for an estimated annual amount of \$47,422.08; and

WHEREAS, the City may terminate the agreement with or without cause upon 30 days' written notice; and

WHEREAS, award is subject to the City receiving all insurance required and approved by the City's Risk Manager, along with signed statements of Hold Harmless and Indemnity to the City; and

WHEREAS, funding for the agreement has been provided in the Fiscal Year 2018 Budget in the Police Department's Vehicle Rental Account Number 01.2042.00297.521.004005, and funding will be requested in subsequent Fiscal Years.

NOW, THEREFORE, BE IT RESOLVED BY THE CITY COMMISSION OF THE CITY OF HOLLYWOOD, FLORIDA:

Section 1: That the foregoing "WHEREAS" clauses are ratified and confirmed as being true and correct and are incorporated in the Resolution.

<u>Section 2:</u> That it approves and authorizes the issuance, by the appropriate City officials, of the attached blanket purchase order between Alligator Alley Harley-Davidson of Fort Lauderdale, Florida and the City of Hollywood, together with such non-material changes as may be subsequently agreed to by the City Manager and approved as to form and legal sufficiency by the City Attorney.
