- Peterson's Harley-Davidson of Miami, L.L.C. Miami, Florida
  - (Option A) \$650.00/month/motorcycle (Non-Responsive)
    - (Option B) \$750.00/month/motorcycle
- Alligator Alley Harley
  - 658.64/month/motorcycle

Fort Lauderdale, Florida

This Resolution recommends that the City Commission approve the issuance of the attached Blanket Purchase Order with Alligator Alley Harley for the lease of six (6) Harley-Davidson Police Motorcycles at a cost of \$658.64 per month, per motorcycle, for a two (2) year period with the option to renew for one additional two (2) year period, providing any renewals are in best interest of the City in an estimated annual amount of \$47,422.08.
