This Resolution seeks authorization for the appropriate City Officials to execute the attached Authorization To Proceed for Work Order CTA 18-01 to Craven Thompson and Associates, Inc. in the amount of \$1,055,170.88. This agreement is to provide Professional Engineering Services for the Department of Public Utilities with the Driftwood Septic to Sewer Conversion Phase 1.

The City Commission has directed the Department of Public Utilities to provide Sanitary Sewer to the areas in the city without Sanitary Sewer Services. The Department has determined the most efficient and economical way to provide the service is during the Page 2 BIS 18-121 File TMP-2018-102

implementation of the Water Main Replacement Program. Water Main Replacement Project No. 12-5117 (Taft Street to Charleston Street from 66th Avenue to 72nd Avenue) corresponds with proposed Driftwood Septic to Sewer Conversion Phase 1.
