**SUBJECT:** Enterprise Equity Lease Agreement Pilot Program

## ISSUE:

The Department of Public Works seeks approval to continue to utilize the Enterprise Equity Lease Agreement for Code Enforcement vehicles for an additional 14 month term.

## **EXPLANATION:**

In February of 2017, the Department of Public Works entered into an open end vehicle agreement for two, seven months terms. This 14 month agreement provided a total of 32, 2017 GMC Sierra 1500 4x2 double cab pickup trucks. Enterprise provided 16 vehicles in two, seven months increments.

The total cost for the first allocation of 16 vehicles, including lease payments, magnetic LED light bars, magnetic labels, vehicle numbering, window tinting, title fees and The light bars, magnetic labels, and tags were municipal tags was \$59,677.04. transferable to the next allocation and will be available for future allocations, see the table below.

The vehicles were not immediately returned to Enterprise at the end of the first seven month term, because they were utilized in response to Hurricane Irma; one was damaged as a result of the storm. When all 16 were returned, they were subsequently sold, even the damaged vehicle, and the City received an equity payment from Enterprise in the amount of \$72,208.19. The second allocation of 16 vehicles are scheduled to be returned to Enterprise on April 30<sup>th</sup> 2018, ending the 14 month pilot program. Enterprise projects the re-sale of the second allocation of 16 vehicles to result in a similar re-sale value and equity payment as the first allocation of 16 vehicles.

In summary, the revenue received to the City from Enterprise as an equity payment that resulted from the sale of the first allocation of 16 vehicles was greater than the expense of the first seven months of the lease agreement, including equipment and outfitting costs for those same 16 vehicles.

At this time, it is recommended to continue this pilot program for one additional 14 month cycle; which are two, seven month terms, a total of 34, 2018 GMC Sierra 1500 4x2 Double Cab pickup trucks, in increments of 17 vehicles each term. The additional two vehicles (one each term) are necessary as a vacant position is scheduled to be filled.

## **RECOMMENDATION:**

The Department of Public Works recommends the Procurement Services Department seek Commission approval to continue to piggyback the City of Lauderdale Lakes contract with Enterprise FM Trust for an open end lease agreement for municipal utility vehicles and continue this pilot program to provide vehicles for Code Compliance operations.
