

**FIRST AMENDMENT TO THE CONTRACT BETWEEN THE CITY OF
HOLLYWOOD, FLORIDA AND ENVIROWASTE SERVICES GROUP, INC.
FOR THE GRAVITY SEWER SYSTEM CONDITION ASSESSMENT,
RENEWAL AND REPLACEMENT PROGRAM (INFLOW/INFILTRATION I/I)
EXCAVATED POINT REPAIRS**

THIS FIRST AMENDMENT to the Contract dated April 10, 2017, is hereby made and entered into on _____, 2018, by and between the City of Hollywood, a municipal corporation of the State of Florida ("City") and Envirowaste Services Group, Inc., a Florida Corporation, authorized to do business in the State of Florida ("Envirowaste").

RECITALS

WHEREAS, on April 10, 2017, the City and Envirowaste entered into a contract pursuant to Resolution No. R-2017-073 for the gravity sewer system condition assessment, renewal, and replacement program (level 2) excavated point repairs, as identified in the 2007/2008 Wastewater System Master Plan (Project No. 16-7081); and

WHEREAS, Envirowaste has completed all the work identified under the current contract which expires on April 11, 2019; and

WHEREAS, based on the findings of the 2007/2008 Wastewater System Master Plan and previously performed Sanitary Sewer System Evaluation Surveys, the Department of Public Utilities staff has identified additional sanitary sewer basins which require detailed evaluation and potential repair work; and

WHEREAS, as this project is ongoing and Envirowaste has extensive familiarity and knowledge of the City's system, and in order to continue the continuity of the project without disruption, staff has determined that it is in the best interest of the City to amend the existing contract; and

WHEREAS, on _____, 2018, the City Commission passed and adopted Resolution No. R-2018-_____, authorizing the execution of this First Amendment.

NOW, THEREFORE, in consideration of the mutual covenants herein, and for other valuable consideration received, the receipt and sufficiency of which are hereby acknowledged, the parties agree as follows:

1. That the term of this First Amendment shall commence on April 4, 2018 to April 11, 2019.

2. That the contract sum for the work described on Exhibit "A" attached hereto and incorporated by reference, shall be \$1,166,705.00.
3. All other terms and conditions of the April 10, 2017 Contract shall apply to the work outlined in Exhibit "A" and said terms and conditions shall remain in full force and effect.
