A RESOLUTION OF THE CITY COMMISSION OF THE CITY OF HOLLYWOOD, FLORIDA, AUTHORIZING THE APPROPRIATE CITY OFFICIALS TO EXECUTE A PURCHASE ORDER WITH ROBERT HALF INTERNATIONAL, INC. FOR PROFESSIONAL SERVICES TO SUPPORT THE INFORMATION TECHNOLOGY DEPARTMENT FOR AN ESTIMATED AMOUNT NOT TO EXCEED \$62,900.00.

WHEREAS, on January 31, 2018, five firms were solicited to assess interest and obtain pricing for professional temporary services in the field of Senior Systems Analyst: InSight Global, Robert Half International, Inc. ("Robert Half"), MS Consulting, Kforce, and Panorama Consulting; and

WHEREAS, Robert Half provided the best qualified candidate to meet Information Technology operational requirements; and

WHEREAS, the pricing submitted by Robert Half will result in an estimated amount not to exceed \$62,900.00; and

WHEREAS, by approving this Resolution, the City will be able to fill this position without delay; and

WHEREAS, all applicable procurement sections will be adhered to in accordance with the City's procurement guide; and

WHEREAS, funding for the attached agreement has been appropriated and exists in account number 57.1347.00000.590.003117; and

WHEREAS, funding will be only obligated as labor for professional services which are approved to support City projects.
