WHEREAS, the CITY and CONTRACTOR entered into an agreement for Sulfuric Acid 93% in Bulk pursuant to ITB #2012-13/18; and

WHEREAS, the initial CONTRACT term is three (3) years, beginning June 1, 2013 and expiring May 31, 2016; and
