WHEREAS, currently William Campanella serves in the capacity as Registered Architect and his term expires on June 30, 2018; and

WHEREAS, currently, John Lipka serves in the capacity as Electrical Contractor and his term expires on June 30, 2018; and

WHEREAS, currently Heather Harmon serves in the capacity as Attorney at Law, and her term expires on June 30, 2018; and

WHEREAS, the Plumbing Contractor position has remained vacant, and the current term expires June 30, 2019; and

WHEREAS, currently Jan Lederman services in the capacity as Real Estate Property Manager and his term expires June 30, 2018; and

WHEREAS, the City Clerk provided notice to the public that positions were available and solicited interest forms from citizens to fill available vacancies; and
