A RESOLUTION OF THE CITY COMMISSION OF THE CITY  
OF HOLLYWOOD, FLORIDA, APPOINTING SEVEN  
MEMBERS TO THE PARKS, RECREATION AND  
CULTURAL ARTS ADVISORY BOARD.

WHEREAS, the City of Hollywood, Parks, Recreation and Cultural Arts Advisory Board ("Board") was established by the City Commission to promote parks, recreation, cultural arts, special events and golf operations within the City; and

WHEREAS, the Board consists of nine adult members and two youth members whose interests and focus are on the recreational, athletic or cultural arts aspects of the Department; and

WHEREAS, the Board identifies goals and objectives on an annual basis and provides input on capital improvement projects and community needs, as they relate to the Department; and

WHEREAS, Kimberly Norment-Schmitt, Tom Tianich and Larry Zolot currently serve as Adult Members and their terms expire on June 30, 2018; and

WHEREAS, due to the removal of Earl Broughton, who served as an Adult Member, there is now a vacancy which must be filled for the remainder of his term expiring on June 30, 2019; and

WHEREAS, due to the removal of Charles Pepin, who served as an Adult Member, there is now a vacancy which must be filled for the remainder of his term expiring on June 30, 2020; and

WHEREAS, currently Shelby Gronvold serves as a Youth Member and her term expires on June 30, 2018; and

WHEREAS, currently there is a vacancy, which was never filled, for another Youth Member, which term expires on June 30, 2018; and

WHEREAS, the City Clerk provided notice to the public that positions were available and solicited interest forms from citizens to fill available vacancies; and
