WHEREAS, Board members are appointed based upon their interest in the arts and culture and backgrounds in the categories of visual arts, performing arts, tourism, arts community-at-large, education, and a resident with extensive art and culture background; and

WHEREAS, the purpose of the AAB is to make recommendations to the City Commission on the operational management structure, proposed facility modifications, and programming of the ArtsPark, and the AAB has no budgetary powers; and

WHEREAS, the following members terms expire on June 30, 2018: (1) Performing Arts Field, James Bond; (1) Extensive Art & Culture Background – Hollywood Resident Field, Henry Grunberg; (1) Arts Community At Large Field, Daniel Reinfeld; (1) Broward County School System Field, Jacqueline Carrero; and (1) Citizen-At-Large- Hollywood Resident Field, David Harris; and

WHEREAS, the City Clerk provided notice to the public that positions were available and solicited interest forms from the community to fill the current vacancies; and
