A RESOLUTION OF THE HOLLYWOOD, FLORIDA
COMMUNITY REDEVELOPMENT AGENCY ("CRA"),
AUTHORIZING THE APPROPRIATE CRA OFFICIALS TO
EXECUTE A CONTRACT WITH _____, FOR THE
REBID OF THE LIFEGUARD AND FIRST AID STATIONS
PROJECT IN THE AMOUNT OF \$_____,
SUBJECT TO THE OUTCOME OF ANY BID PROTEST.

WHEREAS, the CRA Board passed Resolution No. R-CRA 2017-05, authorizing the appropriate CRA officials to negotiate and execute a contract with the highest ranked firm selected, CPZ Architects, to provide architectural and engineering services for 20 lifeguard towers and first aid stations; and

WHEREAS, CPZ Architects was selected as the consultant and was authorized to proceed to develop construction documents for the lifeguard towers and first aid stations; and

WHEREAS, on April 2, 2018, the CRA bid out this project as low bid, and on May 7, 2018, two bids were received and opened; and

WHEREAS, the low bidder submitted an unresponsive bid and the second bidder's bid was significantly higher than the estimated budget; and

WHEREAS, in order to lower the construction cost to an acceptable amount, some revisions were made; and

WHEREAS, construction documents were revised and rebid as per Rebid BCRA 16-002 dated May 30, 2018; and

WHEREAS, three bids were received and publicly opened at 10:00 A.M. on Monday, July 2, 2018, and the results are as listed below:

WHEREAS, after all bids received were evaluated, the Executive Director of the CRA found the bid submitted by _____ to be the lowest responsive, responsible bid, and the Executive Director of the CRA recommends the award of this contract to _____, in the amount of \$_____; and

WHEREAS, the bid protest period is five business days starting July 2, 2018, and award of this bid is subject to the outcome of any bid protest that may be timely submitted after the adoption of this Resolution.

NOW, THEREFORE, BE IT RESOLVED BY THE HOLLYWOOD, FLORIDA, COMMUNITY REDEVELOPMENT AGENCY:

Section 1: That the foregoing "WHEREAS" clauses are ratified and confirmed as being true and correct and are incorporated in this Resolution.

Section 2: That it cancels bid No. CRA-2018-_____.

Section 3: That it approves and authorizes the execution, by the appropriate CRA officials, of a contract embodying the terms and conditions approved by the CRA Board on this date with _____, in the amount of \$_____, in a form acceptable to the CRA Executive Director and approved as to form and legal sufficiency by the CRA General Counsel.

Section 4: That awarding of this contract is subject to the outcome of any protest of this bid that may be timely submitted after the adoption of this Resolution.

Section 5: That this Resolution shall be in full force and effect immediately upon its passage and adoption.
