A RESOLUTION OF THE CITY COMMISSION OF THE CITY OF HOLLYWOOD, FLORIDA, APPROVING AND AUTHORIZING THE APPROPRIATE CITY OFFICIALS TO EXECUTE A CONTRACT WITH EAGLE PAINTING FOR THE PAINTING OF BUILDINGS AND STRUCTURES AT THE SOUTHERN REGIONAL WASTEWATER TREATMENT PLANT IN THE AMOUNT OF \$151,782.69; AND APPROVING AND AUTHORIZING AN AMENDMENT TO THE FISCAL YEAR 2018 CAPITAL IMPROVEMENT PROGRAM. (PROJECT NO. 18-9096C)

WHEREAS, there is a need for structure surface preparation and painting of buildings and various structures at the Southern Regional Wastewater Treatment Plant in order to prevent additional deterioration and damages to the facilities and equipment; and

WHEREAS, on April 19, 2018, Department of Public Utilities staff advertised the project soliciting qualified construction services, and on May 24, 2018, six bid proposals were received at the Office of the City Clerk and were publicly opened at the City's Southern Regional Wastewater Treatment Plant, with the following results:

WHEREAS, after thoroughly evaluating the bid proposals for compliance with the contract documents, Department of Public Utilities staff determined the bid proposal received from J&J, Inc., d/b/a Eagle Painting, is the lowest responsive and responsible bidder; and

WHEREAS, the bid proposal received from Miami Nice Painting, Inc., had several bid items blank and therefore was deemed non-responsive; and

WHEREAS, a Notice of Intent to Award related to the project was posted on the City's website and on DemandStar on June 14, 2018, and resulted in no bid protests; and

WHEREAS, Administration recommends that the City Commission approve and authorize the appropriate City officials to execute the attached contract with J&J, Inc., d/b/a Eagle Painting, in the amount of \$151,782.69; and

WHEREAS, it is necessary to amend the approved FY2018 Capital Improvements Program and allocate funding in the amount of \$151,782.69, as set forth in the attached Exhibit "A"; and

WHEREAS, the estimated construction time for this project is 180 calendar days from the Notice to Proceed date.

NOW THEREFORE, BE IT RESOLVED BY THE CITY COMMISSION OF THE CITY OF HOLLYWOOD, FLORIDA:

- <u>Section 1</u>: That the foregoing "WHEREAS" clauses are ratified and confirmed as being true and correct and are incorporated in this Resolution.
- <u>Section 2</u>: That it approves and authorizes the execution, by the appropriate City officials, of the attached contract with J&J, Inc., d/b/a Eagle Painting, together with such non-material changes as may be acceptable to the City Manager and approved as to form and legal sufficiency by the City Attorney.
- Section 3: That it approves and authorizes an amendment to the approved FY2018 Capital Improvement Program, as more specifically set forth in the attached Exhibit "A".

<u>Section 4</u>: That this Resolution shall be in full force and effect immediately upon its passage and adoption.
