This Resolution seeks authorization for the appropriate City Officials to execute a license and maintenance agreement with Azteca Systems, LLC for Software and Maintenance and Technical support services. The annual cost of the acquisition and support is \$60,000.00.

The Department of Public Utilities has used the current Maintenance Management Information System (MMIS) Accela software since 2005, however, it has become obsolete, and the newer versions of the system do not meet the needs and the progressive vision of the department. After an extensive search and detailed evaluation the Department finds it in the best interest of the City to acquire the Cityworks Server Page 2 BIS 18-245 File TMP-2018-445

Asset Management Solution (Cityworks) Premium which currently possesses the most capabilities required in any Computerized Maintenance Management System (CMMS). Section 38.40(C)(10)(a) of the Code of Ordinances provides that software licensing and maintenance with the company from which the software was purchased is not subject to the competitive procurement requirements.

Funding for this agreement is in the Fiscal Year 2018 budget in the Department of Public Utilities Account Number 42.4000.90077.536.006442 provided via Resolution R-2017-295 which continued the appropriation for previously approved capital projects from Fiscal Year 2017 to Fiscal Year 2018. Funding will be budgeted in subsequent fiscal years subject to the passage and adoption of each subsequent fiscal year's Operating Budget by the City Commission.
