A RESOLUTION OF THE HOLLYWOOD, FLORIDA COMMUNITY REDEVELOPMENT AGENCY ("CRA"), AMENDING THE ANNUAL BUDGET FOR THE BEACH DISTRICT OF THE CRA FOR FISCAL YEAR 2018; REVISING OPERATING REVENUES; REVISING EXPENDITURES; AND PROVIDING FOR AN EFFECTIVE DATE.

WHEREAS, on September 27, 2017, pursuant to Resolution No. R-BCRA-2017-31, the CRA adopted a Budget for Fiscal Year 2018 for the Beach District of the CRA; and

WHEREAS, the Budget was adopted based on preliminary projections of Fiscal Year 2018 revenues and expenses; and

WHEREAS, Resolution No. R-BCRA-2017-31 specifically set forth that the budget may be amended when final information is available and as may be otherwise advisable from time to time during the fiscal year; and

WHEREAS, on November 1, 2017, pursuant to Resolution No. R-BCRA-2017-44, the CRA amended the FY 2018 annual budget for the Beach District; and

WHEREAS, on December 6, 2017, pursuant to Resolution No. R-BCRA-2017-50, the CRA amended the FY 2018 annual budget for the Beach District; and

WHEREAS, on January 17, 2018, pursuant to Resolution No. R-BCRA-2018-02, the CRA revised the FY 2018 expenditures for the Beach District; and

WHEREAS, on July 3, 2018, pursuant to Resolution No. R-BCRA-2018-19, the CRA revised the FY 2018 expenditures for the Beach District; and

WHEREAS, certain routine and periodic budgetary adjustments and transfers are appropriate; and

WHEREAS, since the adoption and subsequent amendment of the Budget, it is necessary to amend and revise the annual budgeted revenues and expenditures, as more specifically described in the attached Exhibits "A", "B", and "C".
