## RESOLUTION NO. R-CRA 2018-

A RESOLUTION OF THE HOLLYWOOD, FLORIDA, COMMUNITY REDEVELOPMENT AGENCY ("CRA"), AMENDING RESOLUTION NO. R-CRA-2017-40 TO CHANGE THE LENGTH OF STAY AT EACH LOCATION FOR THE TWO CRA PARKLETS IN THE PARKLET PILOT PROGRAM; CLARIFYING THE PARKLET RENTAL FEES; AND PROVIDING FOR AN EFFECTIVE DATE.

WHEREAS, on October 4, 2017, the CRA Board passed and adopted Resolution R-CRA-2017-40, which directed CRA staff to implement a Parklet Pilot Program for a one year period in the Downtown CRA; and

WHEREAS, CRA had an existing parklet and staff determined that the best location for the existing parklet was 1906 Harrison Street, currently operated as The Tipsy Boar Gastropub; and

WHEREAS, CRA staff has designed and constructed a new parklet to be used in angled spaces along Hollywood Boulevard; and

WHEREAS, CRA staff determined that the best location for the CRA's new parklet is 1921 Hollywood Boulevard, currently operated as Mickey Byrne's Irish Pub & Restaurant; and

WHEREAS, both parklets would travel every 30 days under the Parklet Pilot Program; and

WHEREAS, the CRA desires to have both parklets remain in place until January 31, 2019, and then each parklet will be relocated to a second location, selected from among businesses that have qualified for the Parklet Pilot Program until July 31, 2019; and

WHEREAS, the CRA shall pay the following fees to the City for the parking spaces and these fees shall not include the FDOT café table standard fee which shall be paid by the applicant to the City:

NOW, THEREFORE, BE IT RESOLVED BY THE CITY COMMISSION OF THE CITY OF HOLLYWOOD, FLORIDA:

<u>Section 1</u>: That the foregoing "WHEREAS" clauses are ratified and confirmed as being true and correct and are incorporated in this Resolution.

Section 2: That it approves and authorizes the CRA to require the two parklets to remain in place until January 31, 2019, at which time they will each be relocated to a second qualified location.

Section 3: That the CRA shall pay the following fees to the City for the parking spaces (which do not not include the FDOT café table standard fee to be paid by the applicant to the City):
