A RESOLUTION OF THE HOLLYWOOD, FLORIDA COMMUNITY REDEVELOPMENT AGENCY ("CRA") AMENDING THE ANNUAL BUDGET FOR THE BEACH DISTRICT OF THE CRA FOR FISCAL YEAR 2019; REVISING FISCAL YEAR 2019 REVENUES AND EXPENDITURES; AND PROVIDING AN EFFECTIVE DATE.

Explanation:

On September 26, 2018, pursuant to Resolution No. R-BCRA-2018-32, the CRA adopted a Budget for Fiscal Year 2019 for the Beach District of the CRA. The Budget was adopted based on preliminary projections of Fiscal Year 2019 revenues and expenses. Resolution R-BCRA-2018-32 specifically set forth that the Budget may be amended when final information is available and as may be otherwise advisable from time to time during the fiscal year. On October 10, 2018, the final certified property values were made available by the Broward County Property Appraiser to the CRA. The final certified property values are less than the projected values upon which the adopted Fiscal Year 2019 budget was based by the CRA.

The CRA Beach District's taxable assessed value has decreased slightly from \$3,367,268,860 to \$3,352,457,280, a loss of \$14,811,580. As such, the total increment revenue to the Beach Community Redevelopment Agency will decrease from \$35,992,645 to \$35,802,786, a difference of \$189,859.

Below are charts comparing the approved and the associated increment that is generated from the three (3) separate taxing authorities to the final rates and increment revenues:
