I know this is my first review of the executive CRA director but it's not the first director I have had the opportunity to work with especially in the beach district.

Since Richard Sala, and the four previous executive/interim directors in the prior 14 years, Jorge Camejo has been the 1st to get the Beach CRA redevelopment moving forward. In addition, in 2015 the BCRA was at risk of dissolution and Mr. Camejo recommended refunding TIF back to the city. With the support of the board and commission, city manager, city attorney and CRA the even better designed Interlocal Agreement with the County got done in 2018.

With today's leadership, the two CRA's have under gone restructured staffing and brought in very talented people, relocated the office and gained better exposure, uses best practices, uses available city departments and has engaged property owners to use PIP, HIP, POP & other granting opportunities in both districts.

Goals for the coming year will be to get the beach garage opened, complete plan and design of A1A/FDOT project as relates to CRA, continue planning and design for Phase IV streetscape and engineering for the A1A undergrounding of utilities and to work with FDOT on Hollywood Boulevard entrance to A1A. For the downtown CRA there is now an opportunity to increase the life up to 16 more years. The projects in the planning and building pike will increase TIF and afford the DCRA to get on with infrastructure projects.

I attest that Jorge Camejo is well suited for this position to bring the CRA districts forward with a steady momentum and meeting these goals.

I recommend that the wage of the executive director of the CRA be brought to the level of industry standards where there is one director for two CRA's with comparable budgets.

**Remarks:** I recommend that there should be a review of the enhanced service interlocal agreement to add accountability for all truly enhanced services monies. In the case where there was no baseline the service performed should be billed to and paid by the CRA.

- CONTINUE TO UPDATE THE BOARD ON THE PROGRESS OF PROJECTS LEADING TO THE SUNSET DATE.

WE, AND THE COMMUNITY, WANT AND NEED TO KNOW THAT WHAT WAS COMMITTED IN THE MASTER PLAN, WHICH WE UPDATE AND APPROVE ANNUALLY, IS ON SCHEDULE OR TARGET.

This will make a lasting impression on the residents that the Beach CRA is valuable to the city and should remain until it's natural life is set to end.

Jorge is working constantly to bring the beach to it's highest capacity and now with the new developments downtown we will see a similar very upbeat scenario. Jorge handles a large team to make everything that is needed by both districts to work well.

I look forward to the CRA hip, hop, and pop grants to be used in Parkside to encourage Bed & Breakfasts to development. I think that helping to rehab one complete block in Parkside will prove to investors what can be done to make the area a place to be. We also need to think of outside of the box ideas for Royal Poinciana. The shuttle that will be starting soon will bring both these neighborhoods and all of Hollywood to a comfortable experience downtown.

I am very happy with Jorge's decisions concerning having consultants come in with ideas for Dixie Hwy., the commuter FEC station, and Young Circle Traffic. These were very valuable opportunities not only for the commission but also for the involvement of the community.

I also look forward to Jorge seeking out again to work towards an Artist's live in community.
