A RESOLUTION OF THE HOLLYWOOD, FLORIDA, COMMUNITY REDEVELOPMENT AGENCY ("CRA"), TERMINATING BLANKET PURCHASE ORDER B002646 WITH MYDATT SERVICES, INC., D/B/A BLOCK BY BLOCK, FOR SANITATION AND SAFETY SERVICES IN THE DOWNTOWN DISTRICT FOR AN ANNUAL AMOUNT NOT TO EXCEED \$299,869.87.

WHEREAS, R-DCRA-2014-57 authorized appropriate CRA officials to issue Blanket Purchase Order B002646 for maintenance and safety services in the Downtown Hollywood CRA District; and

WHEREAS, the CRA piggybacked off of the Coconut Grove Business Improvement District of Miami, Florida, Request for Proposal Number 14-601, for what were referred to as sanitation and security services; and

WHEREAS, redevelopment and activity have increased the Downtown District's maintenance and safety needs to a level that is not covered by Blanket Purchase Order B002646; and

WHEREAS, the CRA desires to terminate Blanket Purchase Order B002646; and

WHEREAS, the CRA reserves the right to terminate this blanket purchase order with or without cause; and

WHEREAS, on July 26, 2018, a Notice of Bid Availability for RFP-4580-18-JE for the provision of a clean and safe ambassador program was posted on the City's Website, advertised and sent to 6,333 firms and viewed by 65 vendors on Bidsync.com in accordance with Section 38.42(A)(1) of the City's Purchasing Ordinance; and

WHEREAS, based on immediate award of RFP-4580-18-JE, the CRA is prepared to provide maintenance and safety services in the Downtown Hollywood CRA District post termination of Blanket Purchase Order B002646.

NOW, THEREFORE, BE IT RESOLVED BY THE HOLLYWOOD, FLORIDA COMMUNITY REDEVELOPMENT AGENCY:

Section 1: That the foregoing "WHEREAS" clauses are ratified and confirmed as being true and correct and are incorporated in this Resolution.
