

SiteMed Tuberculosis Program Policy

As part of your physical exams, you have chosen to have SiteMed provide a Tuberculosis Screening Program.

SiteMed applies on-site Tuberculosis Skin Tests (PPD) at phase 1 (blood collection). The readings can be done as follows:

1. Your department appoints one person in charge, such as a City Nurse or Paramedic with experience in reading PPD skin tests. The test is to be read 48 to 72 hours after application. Test results will be reported to SiteMed in writing within 5 business days. SiteMed will provide video and written training on reading PPD skin tests and all paperwork. \$25 per person

OR

2. SiteMed can return to your department to read the tests 48 to 72 hours after application. Cost will vary depending on number of days/hours and location

SiteMed will provide a Tuberculosis Screening questionnaire for each participant to fill out prior to phase 1 to determine if they are eligible to have a PPD skin test placed. If our team determines they are not eligible for a PPD skin test, we will perform a QuantiFERON TB Gold Plus Test instead. The cost for this test is \$95 per person.

QFT has been shown to be more accurate than the PPD in identifying people who may have latent TB (tuberculosis) infection or those who may progress to active TB..

If a participant has a positive reaction to the PPD test (10mm or greater), SiteMed will perform a QuantiFERON TB Gold Plus Test at phase 2. The cost for this test is \$95 per person
