A RESOLUTION OF THE CITY COMMISSION OF THE CITY OF HOLLYWOOD, FLORIDA, AMENDING RESOLUTION NO. R-2017-217 TO ALLOW FIFTEEN MINUTE METERED PARKING IN THE DOWNTOWN AREA AND ESTABLISHING THE RATE FOR THE METERED PARKING.

WHEREAS, on July 3, 2017, the City Commission passed and adopted Resolution No. R-2017-217 which reestablished paid parking in the downtown area and eliminated the three hour free on-street parking program in the areas of paid parking; and

WHEREAS, the City Commission set the conditions of the parking program in Resolution No. R-2017-217, including paid on-street parking in the downtown area (boundaries: west – Dixie Highway, east -17th Avenue, south - Washington Street, north – Taylor Street), with no limit and enforced 24 hours per day every day, and the establishment of a \$1.50 an hour rate; and

WHEREAS, businesses have requested fifteen (15) minute metered parking be allowed in certain areas of downtown for short-term parking at businesses with rapid transaction times; and

WHEREAS, the proposed amendment would allow the Parking Administrator to review each fifteen (15) minute metered parking location and adjust parking times to meet nearby business needs and overall downtown parking needs.

NOW, THEREFORE, BE IT RESOLVED BY THE CITY COMMISSION OF THE CITY OF HOLLYWOOD, FLORIDA:

<u>Section 1</u>: That the foregoing "WHEREAS" clauses are ratified and confirmed as being true and correct and are incorporated in this Resolution.

Section 2: That Section 1 of Resolution R-2017-217 is amended to establish fifteen (15) minute metered parking in the downtown area where designated by the Parking Administrator.

Section 3: That Exhibit "C" of Resolution No. R-2017-217 as it relates to Metered Street and Lot Parking Rates for the Downtown area is amended to establish the metered parking rate for the fifteen (15) minute parking, as more specifically set forth in the attached Exhibit "C".

Section 4: That this Resolution sha and adoption.	II be in full force and effect upo	on its passage

Three Required Documents to Prove Residency:

- 1. Valid photo ID issued by local, state or federal agency (driver's license, passport); and
- 2. Valid vehicle registration belonging to the person applying for the resident rate; and
- 3. Current utility bill such as electric, gas, cable or phone which matches the resident's name and address. The current statement must have been mailed within the last 30 days.
