GENERAL CONSULTING SERVICES

Brown and Caldwell will provide professional engineering and administrative support on an as-needed basis as directed by the City of Hollywood Department of Public Utilities' Director, Deputy Director, or Assistant Director. As stated previously, services to be provided cannot be definitively predicted at this time due to the as-needed nature of this work order, but may include some combination of the following, as well as other, yet to be defined, services:

- 1 Response to City's requests for information;
- 2. Meetings with City's personnel to discuss matters of importance to the utility;
- Meetings with regulatory agencies including Florida Department of Environmental Protection (FDEP), South Florida Water Management District (SFWMD), Broward County Environmental Protection and Growth Management Department (EPGMD), and other agencies, utilities, and organizations, as required;
- 4. Response to requests for additional information from regulatory agencies, other utilities, and organizations;
- Conference calls internal and external;
- 6. Review of materials;
- 7. Development of conceptual planning framework/considerations for matters of emerging interest;
- 8. Technical assessments and development of advisory opinions, including for the Ocean Outfall Legislation;
- 9. Support of other compliance initiatives and reporting requirements;
- 10. Preparation of materials including technical memoranda, hydraulic evaluations, reports, PowerPoint presentations for DPU staff, Commission workshops, Regulatory agencies' workshops, outreach efforts, etc.
- 11. Presentations at meetings/workshops.

COMPENSATION

Brown and Caldwell will perform the aforementioned services for a total fee of \$100,000 to be billed on an hourly rate basis. The specific level of effort for the noted potential services cannot be predicted given the nature of this work order.
