A RESOLUTION OF THE CITY COMMISSION OF THE CITY OF HOLLYWOOD, FLORIDA, APPROVING AND AUTHORIZING THE APPROPRIATE CITY OFFICIALS TO ISSUE BLANKET PURCHASE ORDERS FOR THE RENEWAL OF THE EXISTING AGREEMENTS WITH CALVIN, GIORDANO & ASSOCIATES, INC. AND C.A.P. GOVERNMENT, INC. FOR INSPECTION AND PLAN REVIEW SERVICES IN AN ESTIMATED ANNUAL CUMULATIVE AMOUNT NOT TO EXCEED \$800,000.00.

WHEREAS, on May 16, 2018, the City Commission passed and adopted Resolution No. R-2018-140, which approved and authorized the issuance of Blank Purchase Orders with Calvin Giordano & Associates, Inc. and C.A.P. Government, Inc. to provide inspection and plan review services for the Building Division, in an estimated annual cumulative amount of \$800,000.00; and

WHEREAS, the Blanket Purchase Orders ("BPOs") were issued in accordance with Section 38.40(C)(5) of the City's Purchasing Code, which allowed the City to piggyback the City of Fort Lauderdale's RFP-575-11849 with an initial term of one year and the option to renew for a two year term; and

WHEREAS, as the current BPOs will expire on May 15, 2019, the Department of Development Services, Building Division desires to renew both BPOs under the existing terms and conditions of the initial agreements and to continue utilizing both Calvin, Giordano & Associates, Inc. and C.A.P. Government, Inc. ("Vendors") for the services; and

WHEREAS, both Vendors have agreed to renew the existing agreements under the same terms and conditions, as long as both Vendors continue to provide satisfactory service; and

WHEREAS, Section 38.48(C)(1) of the Purchasing Ordinance provides that, when a contract entered into by the City pursuant to City Commission approval provides for one or more renewals by affirmative action of the City and the estimated annual cost of a renewal exceeds \$250,000.00, only the City Commission is authorized to approve such renewals; and

WHEREAS, funding for the BPOs will be made available in account number 001.140301.52400.531170.000000.000.000, as needed.

NOW, THEREFORE, BE IT RESOLVED BY THE CITY COMMISSION OF THE CITY OF HOLLYWOOD, FLORIDA:

A RESOLUTION OF THE CITY COMMISSION OF THE CITY OF HOLLYWOOD, FLORIDA, APPROVING AND AUTHORIZING THE APPROPRIATE CITY OFFICIALS TO ISSUE BLANKET PURCHASE ORDERS FOR THE RENEWAL OF THE EXISTING AGREEMENTS WITH CALVIN, GIORDANO & ASSOCIATES, INC. AND C.A.P. GOVERNMENT, INC. FOR INSPECTION AND PLAN REVIEW SERVICES IN AN ESTIMATED ANNUAL CUMULATIVE AMOUNT NOT TO EXCEED \$800,000.00.

Section 1: That the foregoing "WHEREAS" clauses are ratified and confirmed as being true and correct and are incorporated in this Resolution.

Section 2: That it approves and authorizes the issuance, by the appropriate City officials, of the attached Blanket Purchase Orders with Calvin, Giordano & Associates, Inc. and C.A.P. Government, Inc., together with such non-material changes as may be subsequently agreed to by the City Manager and approved as to form and legal sufficiency by the City Attorney.

Section 3: That this Resolution shall be in full force and effect immediately upon its passage and adoption.
