

RESOLUTION NO. _____

A RESOLUTION OF THE CITY COMMISSION OF THE CITY OF HOLLYWOOD, FLORIDA, APPROVING AND AUTHORIZING THE APPROPRIATE CITY OFFICIALS TO NEGOTIATE AND EXECUTE AN AGREEMENT WITH THE HIGHEST RANKED FIRM TO PROVIDE A PARKING ACCESS REVENUE CONTROL SYSTEM IN AN ESTIMATED AMOUNT OF \$672,600.44, AND IF NEGOTIATIONS ARE NOT SUCCESSFUL, AUTHORIZING THE APPROPRIATE CITY OFFICIALS TO NEGOTIATE AND EXECUTE AN AGREEMENT WITH THE NEXT HIGHEST RANKED FIRM(S) UNTIL AN AGREEMENT IS REACHED.

WHEREAS, the Parking Division desires to enter into an agreement with a qualified firm to install a turn-key Parking Access and Revenue Control ("PARC") system at the Van Buren and Radius Parking garages; and

WHEREAS, on September 20, 2018 and in accordance with Section 38.42(A)(1) of the City's Purchasing Ordinance, a Notice of Bid Availability for RFP-4596-18-JE was posted on the City's Website and on Bidsync; and

WHEREAS, on October 25, 2018, RFP-4596-18-JE was opened at 3:00 P.M., and resulted in a response from three firms, as follows:

- ◆ Amano McGann
- ◆ Flash Parking
- ◆ Pinnacle Parking Systems; and

WHEREAS, the evaluation of the proposals was based on various factors set forth in the RFP; and

WHEREAS, the proposals were evaluated by three committee members consisting of Hollywood's Parking Administrator, Miami Parking Authority's Director of Operations, and Delray Beach's Chief Parking Administrator; and

WHEREAS, after the proposals were evaluated, the Evaluation Committee scores were tallied to arrive at the scores below, and the Evaluation Committee requested that each firm be invited for oral interviews:

WHEREAS, after the oral interviews, the resultant scores were compiled and the proposals were ranked whereby the lowest score served as the highest ranked proposal:

1. Pinnacle Parking Systems, LLC. 4.0
2. Amano McGann 7.0
3. Flash Parking 7.0; and

WHEREAS, the Director of Development Services and the Director of the Procurement and Contract Compliance recommend that the City Commission approve and authorize the negotiation and execution of an agreement with the highest ranked firm, Pinnacle Parking Systems, LLC., which includes the RFP and Pinnacle's response, to provide a PARC System in the Van Buren and Radius Parking Garages, in an estimated amount of \$672,600.44; and

WHEREAS, a portion of the funding in the amount of \$400,000.00 has been provided pursuant to Resolution No. R-2018-311, which continued the appropriation for previously approved capital projects from FY 2018 to FY 2019 and is available in account number 446.159901.54500.564530.000218.000.000; and

WHEREAS, the remainder of the funding has been provided by amending the Fiscal Year 2019 Operating Budget and Capital Improvement Program with the adoption of Resolution R-2019-047 on March 20, 2019; and

WHEREAS, the City reserves the right to terminate this agreement with or without cause effective 30 days from date of written notice; and

WHEREAS, award is subject to the City receiving all insurance documentation and endorsements required and approved by the City's Risk Manager, along with signed statements of Hold Harmless and Indemnity in favor of the City; and

WHEREAS, if during negotiations an agreement cannot be reached with Pinnacle Parking Systems, LLC., staff shall terminate negotiations with that firm and will continue negotiations with the next highest ranked firm(s), in order, until an agreement is reached and executed.

NOW, THEREFORE, BE IT RESOLVED BY THE CITY COMMISSION OF THE CITY OF HOLLYWOOD, FLORIDA:

Section 1: That the foregoing "WHEREAS" clauses are ratified and confirmed as being true and correct and are incorporated in this Resolution.

A RESOLUTION APPROVING AND AUTHORIZING THE APPROPRIATE CITY OFFICIAL TO NEGOTIATE AND EXECUTE AN AGREEMENT WITH THE HIGHEST RANKED FIRM TO PROVIDE A PARKING ACCESS REVENUE CONTROL SYSTEM.

Section 2: That it hereby ranks the three firms as follows:

Section 3: That it approves and authorizes the appropriate City officials to negotiate and execute an agreement with the highest ranked firm, in a form acceptable to the City Manager and approved as to form and legal sufficiency by the City Attorney.

Section 4: That if the appropriate City officials are unable to negotiate an agreement with the highest ranked firm, they are authorized to commence negotiations with the next highest ranked firm(s), in order, until an agreement is reached and executed.

Section 5: That this Resolution shall be in full force and effect immediately upon its passage and adoption.
