A RESOLUTION OF THE CITY COMMISSION OF THE CITY OF HOLLYWOOD, FLORIDA, RATIFYING THE SUBMISSION OF AN APPLICATION TO THE FLORIDA DEPARTMENT OF TRANSPORTATION TO RECEIVE A SUB-GRANT UNDER THE SAFETY OFFICE HIGHWAY SAFETY SUB-GRANT PROGRAM TO CREATE AN INITIATIVE TO REDUCE TRAFFIC ACCIDENTS FATALITIES INVOLVING AND **INJURIES** BY CONDUCTING DELIBERATE ENFORCEMENT **OPERATIONS THAT TARGET SPEED AND AGGRESSIVE** DRIVING; AUTHORIZING THE APPROPRIATE CITY OFFICIALS TO ACCEPT, IF AWARDED, THE SUB-GRANT APPROXIMATE AMOUNT OF \$40,000.00; IN AN AUTHORIZING THE APPROPRIATE CITY OFFICIALS TO EXECUTE ALL APPLICABLE GRANT DOCUMENTS AND AGREEMENTS; AND IF AWARDED, AMENDING THE FISCAL YEAR 2019 ADOPTED OPERATING BUDGET.

WHEREAS, FDOT awards sub-grants to traffic safety partners that undertake priority area programs and activities to improve safety and reduce crashes, serious injuries, and fatalities; and

WHEREAS, sub-grants are awarded to state and local safety-related agencies to assist in the development and implementation of programs in traffic safety priority areas, and funding for these sub-grants are apportioned to states annually from the National Highway Traffic Safety Administration according to a formula based on population and road miles; and

WHEREAS, if awarded, the Police Department will utilize the sub-grant funds to create an initiative to reduce traffic accidents involving fatalities and injuries by conducting deliberate enforcement operations targeting speed and aggressive driving; and

WHEREAS, if awarded, the acceptance of the sub-grant funds does not require a contribution of matching funds and will incur no cost to the taxpayers of the City; and

WHEREAS, the Chief of Police recommends that the City Commission ratify the submission of the application for the sub-grant; and

WHEREAS, the Chief of Police recommends that if awarded, the appropriate City officials accept the Florida Department of Transportation State Safety Office Highway Safety Sub-grant Program funds in the approximate amount of \$40,000.00.

NOW, THEREFORE, BE IT RESOLVED BY THE CITY COMMISSION OF THE CITY OF HOLLYWOOD, FLORIDA:

<u>Section 1</u>: That the foregoing "WHEREAS" clauses are ratified and confirmed as being true and correct and are incorporated in this Resolution.

<u>Section 2</u>: That it ratifies the submission of the application to the Florida Department of Transportation for sub-grant funding from the Safety Office Highway Safety Program.

<u>Section 3</u>: That the City Manager is authorized to accept the sub-grant, if awarded, and the City Manager shall have the discretion to refuse the sub-grant in those circumstances where he determines it is in the best interest of the City to do so, in which case he shall advise the City Commission of his intention to refuse the sub-grant.

<u>Section 4</u>: That upon the Florida Department of Transportation State Safety Office Highway Safety Sub-grant Program funds being awarded to the City, and the City Manager accepting the award, the appropriate City officials are authorized to execute all applicable grant documents and Agreements in a form acceptable to the City Manager and approved as to form and legal sufficiency by the City Attorney.

<u>Section 5</u>: That it authorizes the Department of Financial Services to create certain accounts to recognize revenue for the program funding, if awarded.

<u>Section 6</u>: That if awarded, the Amendments to the FY 2019 Operating Budget for the Fiscal Year beginning October 1, 2018 and set forth in detail in the attached Exhibit "1" are adopted and authorized as Amendments to the Operating Budget of the Police Grants Fund (Fund 113) of the City of Hollywood, Florida, for the Fiscal Year 2019.
